I. CALL TO ORDER

Chair Ketchel called the meeting to order.

II. APPROVAL OF AGENDA

Chair Ketchel moved for approval of agenda with the addition of consideration to support bus service for the Destin Seafood Festival.

Mayor Hood moved to approve the agenda with the Destin Seafood Festival request. Councilmember Bullard seconded the motion, and it was unanimously approved.

III. CONSENT AGENDA

Approval of the July 29, 2025 Meeting Minutes

Councilmember Stauffer moved to approve the meeting minutes. Mayor Hood seconded the motion, and it was unanimously approved.

V. ACTION ITEMS

 Consideration of bus support for the Destin Seafood Festival – Mr. Tyrone Parker, Okaloosa County

Destin has submitted a request for EC Rider to provide bus support to the Destin Seafood Festival September 26-28, 2025. Support has been provided in past years, and we would be able to support them again this year if approved.

Councilmember Walker asked is the Seafood Festival service is part of transits annual budget.

Mr. Paker stated no, any additional cost incurred for this service is charged to the Seafood Festival and the service is open to the public.

Mayor Hood moved to approve the Seafood Festival request.

Councilmember Bullard seconded the motion, and it was unanimously approved.

VI. INFORMATION ITEMS:

- 1. Comprehensive Operations Analysis Implementation Updates Mr. Tyrone Parker, Okaloosa County
 - Phase 1 adjusted service in Destin.
 - Phase 2 Fort Walton Beach, County Jail, and West Minister Manor.
 - Phase 3 will look at changes in Crestview. Applied for a service development grant. If awarded it can provide 3 years of service – to help kick start additional service to Crestview.

Chair Ketchel asked if a match was required.

Tyrone Parker stated not for the first 3 years if the Service Development is awarded.



2. EC Rider update - Mr. Tyrone Parker, Okaloosa County

- So far, a very busy 2025
 - Several audits Federal Transit Administration, Florida Department of Transportation, and the Florida Commission for the Transportation Disadvantaged.
 - o All audits have come back with positive remarks
 - Covering all areas of transit, checking off numerous points.
 - Waiting for the final reports.
- Board of County Commissioners accepted Capital Grants. To include 5311 for 2 new fixed route buses. These buses will replace existing buses which have reached the end of their life. The buses should be arriving in November or December and are Federally funded. Okaloosa County is fortunate to be able to replace vehicles in a timely manner.

Mayor Hood asked if the buses will be for the rural area, and said she is in favor of increased rural services.

Mr. Parker said yes, they will be.

Councilmember Bullard asked why the new buses could not be used for additional services in the rural areas.

Mr. Parker said the buses are slated as replacement buses and additional funds are needed for increased or additional services.

3. MV Transportation Updates - Mr. John Bohannon

- Staffing MV has 45 drivers for fix and paratransit services.
- Hired 1 driver in August but recently lost 5 drivers.
- Need 12 more, 3 drivers just started, and a few have been approved and will start the process.
- No service is being missed.
- Fully staffed administrative positions.
- August zero accidents for fixed route but there was 1 paratransit accident.
- August 5th was MV's anniversary, good celebration with staff.
- Safety meeting is scheduled for September. Also, it will include a safety blitz and campaign.
- August on time percentage was 90.1%.

Mayor Hood stated she is thankful for the service helping people who cannot drive.



VII. OTHER BUSINESS

Councilmember Walker asked if the total budget for transit was 18 million.

Mr. Parker said the County's contribution is just over 100,000 dollars and grants cover 12 million dollars.

Chair Ketchel added that the contribution is needed for the match requirements.

Councilmember Walker asked about the numbers Shelia Fitgerald had emailed him.

Ms. Fitzgerald said 2024 costs were 7.3 million for capital and operations. Grants and fares covered the majority, and the County covered 100,000 dollars which would be consistent with 2025 numbers.

Councilmember Walker asked what the fare totals are.

Mr. Parker said he would send him the information.

Councilmember Bullard said he supports the County's contribution and would support increasing it. Citizens who use the service contribute and it has a positive return to the community.

Chair Ketchel added transit has had a positive impact and helps reduce traffic. There have been a lot of strides and impact in the past few years.

Mayor Hood said she is an advocate for the medically fragile and underserved who need the service. She agreed that transit helps with a strong economic impact.
