CALL TO ORDER/PLEDGE

Vice Chair Wagner called the meeting to order. The pledge of allegiance was recited, and a moment of silence was held for fallen soldiers.

APPROVAL OF AGENDA

Council Member Sutton moved to approve the agenda as presented. Council Member Capps seconded the motion, and it was unanimously approved.

Vice Chair Wagner asked for introductions of TPO members and staff for the benefit of the new members and the audience. Introductions were made.

PUBLIC FORUM

Ted Corcoran spoke in favor of the Around the Mound project, stating that its completion will be a generational change for the area. He asked that the TPO keep the priority of this project high.

FDOT UPDATES:

Bryant Paulk provided an update on the Statewide SIS Plan's Needs Plan development, soliciting input from the TPO. It covers the most important corridors throughout the district, mostly related to the transfer of goods and services and connectivity to airports and other traffic facilities. Bryant Paulk explained the corridors that are on the SIS network throughout Okaloosa and Walton counties.

Bryant Paulk asked for projects for the Statewide SIS Needs Plan to consider for funding in a Cost Feasible Plan.

Bryant Paulk reported that the resurfacing of Eglin Parkway from Richbourg Avenue in Shalimar to US 98 in Fort Walton Beach will be let for construction in July and workers should be out there by October.

4. ENCLOSURE D - ALL COMMITTEES - Consideration of Resolution O-W 25-04 Adopting the Okaloosa-Walton TPO FY 2027 – FY 2031 Project Priorities

Jill Nobles provided a PowerPoint presentation and explained the project priorities development cycle and where it fits into the overall development of transportation projects from concept to construction. Jill Nobles then explained the types of projects in the priorities and highlighted public comments that were received, specifically changes that were requested by local governments. There was a lot of support for moving the Around the Mound and the PJ Adams Pkwy. /Antioch Rd. at Crab Apple Avenue intersection realignment and signalization project up in the ranking.

Rae Emary provided further information on the public feedback that was received, including an impressive 421 completed surveys. Tourist impacts, school start and stop times, as well as congestion, specifically during peak hours, were the main areas of commute frustration that were reported. Construction zone delays were not listed very high. Most survey takers gave comments and many of them were about congestion on US 98 and SR 85, needed signal timing improvements, more and safer bicycle and pedestrian facilities, and the need for alternative routes.

Scott Davidson said that the survey was widely distributed at Hurlburt Field and many of the comments likely came from personnel there.

Mayor Whitten spoke to the need to move Non-SIS Priority #12 up to address safety and to accommodate the residents of a 150 home subdivision located there. After numerous attempts to alleviate the situation with FDOT, there have been several improvements made, but the requested traffic light has not been approved due to the needed location not being a true intersection. Mayor Whitten explained that aligning Old Antioch Road with Crab Apple is critical to getting the traffic light in place and asked that this project, which has been stalled at #12 for the past three years, be moved to #9.

Commissioner Johns spoke to the need for safety improvements at SR 20 and Thompson Road in Walton County.

Commissioner Anderson spoke to the need for safety features at SR20 and US 331. There are back ups due to accidents on a nearly weekly basis and both roads are critical to moving Walton County.

Council Member Sutton asked Mayor Whitten if there was any way the City of Crestview can contribute funds to the #12 project in order to get it done faster. Mayor Whitten said he would pursue this option and was hopeful.

Commissioner Ketchel suggested swapping projects within each county as opposed to moving projects that would result in others from the adjacent county falling lower in priority. Jill Nobles said the CAC had a similar thought.

There was general discussion about how to proceed and Jill Nobles provided the advisory committee recommendations.

The CAC's recommendation was to approve the Project Priorities with the following changes: 1) move SIS Priority #4 to #2, 2) move the current #12 Non-SIS project higher in priority, at the TPO's discretion, and 3) move the current #9 TSM Priority, SR 189 at Poquito Road, higher in priority, at the TPO's discretion.

The TCC's recommendation was that the TPO add the Perry Avenue one-way study to the Non-SIS Priority #2, Transportation Planning Studies, to keep the current SIS Priority #1, US 98 in the #1 position, to incorporate the DeFuniak Springs Airport priorities as submitted, and asks that if changing the priority of any SIS projects, that such changes should only have an impact on projects within the same county. In other words, to not adversely affect the ranking of the other county's projects.

<u>Commissioner Ketchel moved to re-prioritize the provided draft TSM priorities</u> as follows: #9 becomes #3, #3 becomes #2, and #2 becomes #9. The motion was seconded and was approved by a vote of 13 to 1, with Council Member Tolbert voting in opposition.

Commissioner Mixon moved to switch SIS Priorities #1 and #2, making Priority #1 SR 85 from McWhorter Avenue to PJ Adams Parkway, and making Priority #2 US 98/SR 30 from the Santa Rosa County line to east of Cody Lane interchange. The motion was seconded by Commissioner Ketchel. There was much discussion about the validity and need of each of these projects being ranked #1.

Scott Davidson spoke on behalf of Hurlburt Field, explaining the military mission and critical need of Hwy 98. He thanked the TPO for their hard work on moving this project forward.

There was then discussion of the critical need of other military installations in Okaloosa County.

Vice Chair Wagner called for the vote. <u>The motion passed by a vote of 11 to 3, with Commissioner Anderson, Council Member Sutton, and Council Member Tolbert voting in opposition.</u>

Commissioner Glidewell moved to approve Resolution O-W 25-04 adopting the Okaloosa-Walton TPO FY 2027 – FY 2031 Project Priorities with the changes noted above, and to include the DeFuniak Springs Airport projects as submitted. The motion was seconded Commissioner Mixon and it was unanimously approved.

5. ENCLOSURE E - ALL COMMITTEES - Consideration of Resolution O-W 25-05 Approving the Scope of Services for the Okaloosa-Walton 2050 Long Range Transportation Plan (LRTP) Update and Appointment of Steering Committee Members

Jill Nobles asked for TPO volunteers to serve on the steering committee and provided the names of the CAC and TCC volunteers who would also be serving. Online attendance will be allowed for convenience, and the meetings will start within the next couple of months.

Mayor Wagner and Commissioner Anderson volunteered.

Commissioner Glidewell moved to authorize the TPO chair to sign Resolution O-W 25-05 approving the scope of services for the Okaloosa-Walton TPO 2050 Long Range Transportation Plan update and appointment of Wagner, Tony Anderson steering committee members. Council Member Hayes seconded the motion, and it was unanimously approved.

6. ENCLOSURE F - ALL COMMITTEES – Nomination and Election of TPO Board, TCC, and CAC Chair and Vice Chair for FY 2026

Tiffany Bates stated that it is the time of year for the TPO and its advisory committees to elect officers for the coming year and provided the results of the TCC and CAC elections. Kristen Shell, with the City of Niceville, was elected TCC chair, and Latilda Hughes-Neel was elected TCC vice chair. Amy Jamieson was elected CAC chair, and Robert Rennie was elected CAC vice chair.

There was discussion among the board members regarding who would like to or be willing to serve as the TPO's officers for the upcoming fiscal year.

Commissioner Glidewell moved to elect Mayor Bobby Wagner to serve as TPO chair for FY 2026, Council Member Todd Bierbaum to serve as vice chair, and to ratify the TCC and CAC slate of officers for the same period. Commissioner Anderson seconded the motion, and it was unanimously approved.

7. ENCLOSURE G – TPO ONLY – Appointment of a TPO Member to Serve on the MPOAC for the Remainder of CY 2025

Kandase Lee explained that former Fort Walton Beach Mayor Rynearson was the primary member of the MPOAC Governing Board, and with his departure there is a need to address the MPOAC membership.

Kandase Lee noted that Crestview Mayor JB Whitten, the current alternate, attended the last meeting.

Mayor Whitten stated that he has attended several MPOAC meetings as well as attended the training and would enjoy remaining on the MPOAC Governing Board in some capacity.

<u>Council Member Hayes moved to nominate Mayor JB Whitten as the primary member.</u> Commissioner Ketchel seconded the motion.

Immediately following, Council Member Sutton moved to nominate Mayor Bobby Wagner as the primary member. Council Member Schmidt seconded the motion.

Without proceeding to a formal vote on either motion, the Board conducted a silent (written) vote among the members and Mayor Whitten secured the most votes.

Mayor JB Whitten was selected as the MPOAC Governing Board primary member for the remainder of Calendar Year 2025, and Mayor Bobby Wagner was selected as the alternate member.

SUBJECT: Consideration of Addition of Quest Corporation of America, Inc. as a Subcontractor to the TPO's Consultant Contract

ORIGIN OF SUBJECT: Unified Planning Work Program (UPWP) Task 5: Plans and Studies

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: In August 2023, and in June of 2024, the TPO approved the selection of Kimley-Horn and Associates, along with DRMP and their respective subconsultants, to serve as planning consultants for the Emerald Coast Planning Council and the Florida-Alabama, Okaloosa-Walton, and Bay County TPOs.

In the approved Kimley-Horn contract it states in Section 9.02 "THIRD PARTY CONTRACT – Third parties that are now authorized subcontractors of Kimley-Horn and Associates, Inc. Team include Cambridge Systematics, Inc., Carpe Diem Community Solutions, Inc., Halff Associates, Inc. and HSA Columbia. Expect as noted above and otherwise authorized in writing by ECRC/TPOs, the GPC shall not execute any contract or obligate itself in any other manner with any third party with respect to the project." Kimley-Horn and Associates would like to add Quest Corporation on America, Inc. as an additional subconsultant of to their contract, for marketing services.

To accommodate this requested addition, ECRC/TPO staff received the following statement from Quest Corporation outlining their extensive experience and ability to provide the needed public involvement and outreach services:

ORIGIN OF SUBJECT: Okaloosa Walton TPO Unified Planning Work Program (UPWP) Task 2: LRTP

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The MPO Handbook states: "When developing the LRTP, the MPO must provide interested parties with a reasonable opportunity to comment on it using the strategies identified in the MPO's adopted PPP. In some cases, the MPO may develop a PPP specific to the LRTP as part of the scope of that project. If this is done, the PPP for the LRTP must be consistent with the overall PPP of the MPO. The PPP for the LRTP may provide additional details about engagement strategies being used or individuals, groups, or agencies being engaged. - Private providers of transportation (including intercity bus operators, employer based commuting programs, such as carpool program, vanpool program, transit benefit program, parking cash-out program, shuttle program, or telework program),
- Representatives of users of public transportation,
- Representatives of users of pedestrian walkways and bicycle transportation facilities,
- Representatives of people with disabilities, and
- Other interested parties using the participation plan developed to be consistent with 23 C.F.R. 450.316(a). [23 C.F.R. 450.324(k)]"

Additionally, the FDOT MPO Program Management Handbook, Section 6.3.2, states: The MPO must publish or otherwise make readily available the LRTP for public review, including (to the maximum extent practicable) in electronically accessible formats and means (e.g., the Internet)".

Why is Public Involvement Important?

One of the elements of the Long Range Transportation Plan (LRTP) is public involvement. Engaging more citizens in the planning process leads to a stronger plan that better addresses the community's needs. Providing opportunities for public participation helps minimize challenges in later phases of the plan by identifying and addressing potential issues during the planning stage. The Okaloosa Walton Transportation Planning Organization (TPO) Public Participation Plan (PPP) provides a framework for the development of the Public Involvement Plan (PIP) specific to the Long Range Transportation Plan.

Long Range Transportation Plan

The Long Range Transportation Plan (LRTP) is a federally required document, updated every five years, that addresses future transportation needs for at least a twenty-year horizon.

Public involvement strategies for each LRTP update should incorporate a variety of outreach activities designed to solicit feedback from stakeholders of all ages, communities, and interests throughout all stages of the planning process. Additionally, all outreach activities must adhere to the following procedures, strategies, and desired outcomes outlined in the Code of Federal Regulation (CFR 450.316) and the Metropolitan Planning Organization (MPO) Handbook. These strategies include:

- Provide reasonable public access to technical and policy information used in the development of the LRTP through the Transportation Planning Organization (TPO)/Emerald Coast Regional Council website;
- Provide adequate public notice of public involvement activities and sufficient time for public review and comment on key decisions, such as but not limited to the approval of the LRTP;
- Demonstrate explicit consideration and response to public input received during the plan development process;
- Use visualization techniques to describe the LRTP;
- Hold public meetings at convenient times and accessible locations;
- Seek out and consider the needs of those traditionally underserved by existing transportation systems, including but not limited to low-income and minority households;
- Coordinate with the statewide transportation planning public involvement and consultation processes, as outlined under 23 C.F.R. Subpart B;
- Periodically review the effectiveness of the procedures and strategies contained in the participation plan;

- Incorporate a summary, analysis, and report on the disposition of written and oral comments received on the draft LRTP, including the financial plan, as part of the final LRTP; and
- Provide additional opportunities for public comment if the final LRTP differs significantly from the draft version made available for public comment or if new material issues arise.
- Allow a 30-day formal comment period for major LRTP amendments. Public participation procedures may vary depending on the nature of the amendment.

Stakeholders

Stakeholders will include identified neighborhood associations, affordable housing organizations, community organizations, federally designated and non-federally recognized Native American Tribes, Federal Land Management Agency (FLMA), and major employers in the TPO area. Contact lists will be developed, containing stakeholder emails and phone numbers. These contact lists will be used to promote participation in the LRTP process, facilitate presentations, and help form a steering committee. The steering committee will review key components of the LRTP, including the kick-off meeting, Goals and Objectives, Needs Plan, and Cost Feasible Plan.

Citizens Advisory Committee

The Citizens' Advisory Committee (CAC) is composed of members of the public who have expressed an interest in transportation planning. The TPO board members appoint CAC membership. Citizens interested in learning more about the CAC can email marketing@ecrc.org for additional information.

Technical Coordinating Committee

The Technical Coordinating Committee (TCC) comprises local government and transportation professionals. This committee plays a vital role in the planning process by providing technical advice to the TPO board on transportation-related issues.

Transportation Planning Organization Board

The Okaloosa Walton Transportation Planning Organization serves as this region's and Florida's local intergovernmental transportation policy board. The board is composed of local government officials who make transportation-related decisions at a regional level.

Other TPO Committees

Presentations will be made to other TPO committees and groups as needed to ensure broad engagement and feedback throughout the planning process.

Long Range Transportation Plan Study Area

The Study Area includes Okaloosa and Walton counties in Florida. To ensure that staff effectively reach the right communities and coordinate with agencies and stakeholders in the region, the Okaloosa Walton TPO Community Profile, created as part of the Okaloosa Walton TPO Title VI Plan, will be updated during the information phase of the Long Range Transportation Plan process.




Figure 1: Map illustrating boundaries of the Okaloosa Walton TPO

Public Participation Goals

The Okaloosa Walton 2050 Long Range Transportation Plan incorporates four primary public participation and outreach goals, as outlined in the Okaloosa Walton Public Participation Plan (PPP). These goals are as follows:

Goal 1: Early and Consistent Involvement

Engage the public and stakeholder agencies early in the project and throughout each key phase of the planning process:

- Information Phase Inform the public and stakeholders about the plan's purpose, timeline, major milestones, and how they can stay involved and informed.
- Decision-making Phase Identify specific opportunities for public and stakeholder input at key decision-making points that affect the development of the plan.
- Review Phase Allow the public to review and provide input on a draft version of the completed plan.

Goal 2: Opportunity

Ensure citizens and stakeholder agencies have meaningful opportunities to participate in all phases of the public involvement process. Special emphasis will be placed on engaging traditionally under-represented or under-served communities.

Goal 3: Information and Communication

Provide citizens and stakeholder agencies with clear, timely, and accurate information about the plan as it progresses, ensuring transparency and accessibility.

Goal 4: Range of Techniques

Implement a broad spectrum of outreach techniques to engage the diverse populations within the project area.

To achieve these goals, a range of public involvement and outreach methods will be proposed and utilized during the update of the 2050 Long Range Transportation Plan.



Traditionally, Under-Represented and Under-Served Populations

Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal funds. In addition to considering minority and low-income persons as required by Title VI of the Civil Rights Act of 1964, the TPO identifies and addresses, as appropriate, disproportionately high and adverse human health impacts or economic constraints of its programs, policies, and activities on minority populations and low-income populations within the Okaloosa Walton TPO Study Area.

The Project Team for the 2050 Long Range Transportation Plan will integrate Title VI principles into the planning process as developed and implemented through an ongoing initiative. This effort aims to advance racial equity, support underserved and disadvantaged communities, and identify Economically Constrained Communities for consideration in the 2050 Long Range Transportation Plan.

ZIP codes within Okaloosa and Walton Counties with higher concentrations of minority, transit-dependent, low-income, older adult, and Limited English Proficiency will be identified as Economically Constrained Communities.

Throughout the project, participants in public outreach activities will be asked to provide their residential ZIP codes. The Project Team will periodically analyze participation from these ZIP codes to assess engagement levels in Economically Constrained Communities compared to the broader study area. This analysis will determine the effectiveness of outreach activities in reaching individuals in EJ areas.

If participation from economically constrained communities is disproportionately low, the Project Team will implement targeted measures to improve engagement. For example:

- If a transit-dependent, economically constrained community shows significantly low participation, smaller community meetings or outreach events may be held within the immediate area to minimize travel barriers.
- The Project Team will collaborate with counties and municipalities to identify accessible meeting locations to enhance participation, particularly from priority groups.

These measures aim to ensure inclusive and equitable participation throughout the planning process.



Public Participation and Outreach Strategies

The following methods have proven effective in previous outreach efforts by the TPO and will guide future activities:

- Review previous assessments and LRTP activities to identify successful and unsuccessful public outreach approaches.
- Analyzing Community Profiles to understand the demographics of the TPO Study Area, including traditionally underserved communities, to guide outreach strategies.
- Develop a list of specific public involvement and outreach tasks to include in the draft scope of services.

Specific requirements and strategies for public involvement are outlined in the complete Okaloosa Walton TPO Public Participation Plan, available at www.ecrc.org/OWTPO.

Strategies used by the TPO may include:

Outreach

- Identifying stakeholders, organizations, traditionally underserved communities, tribal organizations, and media outlets.
- Utilizing Virtual Public Involvement (VPI) tools.
- Distributed news releases and conducted radio/TV interviews.
- Posting public notices.
- Creating and distributing surveys with at least a 30-day timeframe for public comment.
- Hosting public open houses, workshops, forums, and focus groups.
- Delivering presentations to civic and community groups.
- Providing comment cards.
- Using GIS maps and other technology tools.
- Developing and staffing a steering committee.

Awareness/Education

- Sending email notifications to stakeholders, organizations, underserved communities, tribal organizations, and media outlets.
- Creating social media posts, hosting events, and/or organizing Virtual Open Houses.
- Maintaining a dedicated section on the TPO website for updates and information.

Documentation

- Compiling survey results and comments.
- Mapping outreach locations using GIS tools.
- Documenting outreach events with photos.
- Tracking email open and click rates.
- Measuring social media engagement.
- Posting oral and written comments alongside draft documents on the TPO website.

Public Meetings

The TPO follows these procedures for public meetings:

- 1. Publishing a legal notice in the newspaper with the largest circulation within the TPO Study Area at least seven days before public meetings. *
- 2. Creating a social media event or post.
- 3. Issuing a news release or a reminder release. *
- 4. Listing the event on the website calendar.
- 5. Send email notifications to TPO/TCC/CAC members, interested parties, and city and county partners.
- * In compliance with the Americans with Disabilities Act (ADA), reasonable accommodations to access information, meetings, and services for individuals with Limited English Proficiency are available upon request. Public Workshops

Public workshops follow the same procedures as public meetings and may also include:

- 1. Emailing flyers to committees, interested parties, public transit providers, and community facilities.
- 2. Posting event details on community event calendars, such as those for libraries and community centers.
- 3. Developing tailored presentations as needed.

Presentations to Groups and Organizations

For presentations to groups and organizations, the following steps will be taken:

- 1. Creating tailored presentation materials as needed.
- 2. Sending a follow-up note of thanks and providing a summary of questions and comments to the meeting coordinator.

Outreach activities will be regularly assessed to evaluate their effectiveness. Adjustments will be made as needed to improve public engagement and ensure inclusivity.

Public Participation Schedule

To ensure the implementation of effective strategies, the public involvement team will provide a public participation schedule as part of the 2050 Long Range Transportation Plan Scope of Work. This schedule will align with the overall LRTP update process and outline specific public outreach strategies for key phases, including kick-off meeting, Goals and Objectives, Needs Plan, and Cost Feasible Plan.

The schedule is available online at www.ecrc.org/OW2050LRTP.

Assessment of Public Participation Strategies

The Okaloosa Walton TPO is committed to evaluating the effectiveness of its public participation strategies to ensure that time and resources are used efficiently and that public participation activities achieve their intended goals. As a standard practice, the TPO evaluates public outreach activities quarterly for all projects and initiatives.

If an assessment indicates that the public participation goals are not being met, strategies may be modified or replaced to improve effectiveness.

The effectiveness of the TPO's public participation activities is measured using the following metrics:

- Number and quality of outreach opportunities.
- Number and reach of social media posts.
- Number of eblasts sent.
- Number of news release subscribers (media, groups, and organizations) and news releases distributed.
- Number of attendees at public workshops and the number of comments received.
- Number of completed surveys.

Regular assessments help the TPO identify areas for improvement and ensure meaningful public engagement in the LRTP process.



The proposed Work Program will then be submitted to the Florida Legislature for adoption. The TPO will develop the final FY 2027-2031 TIP for adoption at the May 2026 TPO meeting, resulting in a TIP and FDOT Work Program that will be consistent.

The FY 2027-2031 Tentative Five-Year Work Programs for Okaloosa and Walton counties will be distributed at the TPO, TCC, and CAC meetings.

ORIGIN OF SUBJECT: Federal Transportation Legislation (MAP-21 (Moving Ahead for Progress in the 21st Century) Act, FAST (Fixing America's Surface Transportation) Act), and Infrastructure Investment and Job Act (IIJA)), Federal Highway Administration, and Florida Department of Transportation

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: Annually, Transportation Planning Organizations (TPOs) are required to adopt targets for Safety Performance Measures by February 27. The TPOs can either accept the DOT targets or establish their own targets (see requirements in the next paragraph). From 2018-2024, the Okaloosa-Walton TPO accepted the FDOT targets for Safety Performance Measures by adopting resolutions and the necessary language for Safety Performance Measures was incorporated into the corresponding Transportation Improvement Programs (TIPs) and amendments. Any future amendments to the 2045 Long Range Transportation Plan will also need to incorporate language for Performance Measures. Because of these previous TPO actions, Resolution 25-13 has been worded to continue with the state targets for Safety as it needs to be adopted by February 27, 2026.

If a TPO agrees to support a State Highway Improvement Program Target, the TPO would

- Work with state and safety stakeholders to address areas of concern for fatalities or serious injuries within the metropolitan planning area.
- Coordinate with the State and include the safety performance measures and the State's Highway Improvement Program targets for those measures in the Metropolitan Transportation Plan.
- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect
 of the Transportation Improvement Program toward achieving Highway Safety Improvement
 Program targets in the Metropolitan Transportation Plan, linking investment priorities in the
 Transportation Improvement Program to those safety targets.

If a TPO establishes its own Safety Performance Target, the TPO would

- Establish Highway Safety Improvement Program targets for all public roads in the metropolitan planning area in coordination with the State.
- Estimate vehicle miles traveled (VMT) for all public roads within the metropolitan planning area for rate targets.
- Coordinate with the state and include the safety performance measures and the TPO's safety targets for those measures in the Metropolitan Transportation Plan.
- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect

of the Transportation Improvement Program toward achieving Highway Safety Improvement Program targets in the Metropolitan Transportation Plan, linking investment priorities in the Transportation Improvement Program to those safety targets.

The Florida Department of Transportation has adopted a "Target Zero" for the five safety measures. This "Target Zero" target is based on the Florida Strategic Highway Safety Plan. The table below illustrates the targets the TPO adopted from 2018-2025 as well as FDOT targets for 2026. The targets are based on a five-year rolling average: 2018 (2012-2016), 2019 (2013-2017), 2020 (2014-2018), 2021 (2015-2019), 2022 (2016-2020), 2023 (2017-2021), 2024 (2018-2022), 2025 (2019-2023), and 2026 (2020-2024).

FDOT'S METHODOLOGY

Florida shares the national traffic safety vision "Toward Zero Deaths," and formally adopted their own version of the national vision, "Driving Down Fatalities." FDOT is committed to eliminating fatalities and reducing serious injuries with the understanding that the death of any person is unacceptable and based on that, zero deaths is the FDOT safety performance target. This target is consistent throughout the FDOT Strategic Highway Safety Plan, Highway Safety Improvement Program and Highway Safety Plan.

Number of Fatalities

Based on statistical forecasting, the five-year rolling average for total fatalities on Florida's roads was forecasted to be 3,423.2 in 2024. Florida's target for fatalities is zero in 2026. The data forecast indicates Florida's five-year rolling average for fatalities will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of traffic fatalities on Florida's roads.

Number of Serious Injuries

Based on statistical forecasting, the five-year rolling average for serious injuries on Florida's roads was forecasted to be 15,564.2 in 2024. Florida's target for serious injuries is zero in 2026. The data forecast indicates Florida's five-year rolling average of serious injuries will continue to trend downward. The FDOT State Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries on Florida's roads.

Fatality Rate

Based on statistical forecasting, the five-year rolling average for fatality rate per 100 million Vehicle Miles Traveled on Florida's roads was forecasted to be 1.510 in 2024. Florida's target for fatality rate per 100 million vehicle miles traveled is zero in 2026. The data forecast indicates Florida's five-year rolling average of fatality rate per 100 million Vehicle Miles Traveled will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the fatality rate per 100 million Vehicle Miles Traveled on Florida's roads.

Serious Injury Rate

Based on statistical forecasting, the five-year rolling average for serious injury rate per 100 million Vehicle Miles Traveled on Florida's roads was forecasted to be 6.868 in 2024. Florida's target for serious injury rate per 100 million Vehicle Miles Traveled is zero in 2026. The data forecast indicates Florida's serious injury rate per 100 million Vehicle Miles Traveled will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries per 100 million Vehicles Miles Traveled on Florida's roads.

Total Number of Non-Motorized Fatalities and Serious Injuries

Based on statistical forecasting, the five-year rolling average for the number of non-motorized fatalities and serious injuries on Florida's roads was forecasted to be 3,145.2 in 2024. Florida's target for number of non-motorized fatalities and serious injuries is zero in 2026. The data forecast indicates Florida's number of non-motorized fatalities and serious injuries will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of non-motorized fatalities and serious injuries on Florida's roads.

SUBJECT: Consideration of Resolution O-W 25-14 Adopting the Congestion Management Process Plan (CMPP) Minor Update

ORIGIN OF SUBJECT: Unified Planning Work Program (UPWP) Task 3: Data Development and Management

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The purpose of the Congestion Management Process Plan (CMPP) is to identify, monitor, and rate the performance of transportation facilities (roadways, bike lanes, sidewalks, and transit services) and to suggest strategies for managing demand and encouraging commuting alternatives and low-cost, short-term actions to alleviate congestion. The CMPP is a tool used to evaluate the performance of transportation facilities by identifying where congestion exists.

The CMPP major update takes place every five years to coincide with the TPO's Long-Range Transportation Plan (LRTP) update. The last major update was adopted in June of 2021 as part of the 2045 LRTP and can be found at: www.ecrc.org/OW2045LRTP. The CMPP reviews specific strategies and projects (such as congested areas and corridors) as a part of the overall identification of opportunities for process improvement.

A minor update takes place on an annual basis and is documented through the CMPP minor update report in order to coordinate its implementation with TIP development. The annual CMPP minor update reflects accomplishments in terms of congestion mitigation expected by the TPO by evaluating the performance measures, LOS tables, the truck traffic map, and producing a Corridor Management Plan on a segment recommended through the annual Project Priorities process. FDOT publishes the annual LOS metrics at <u>FDOT District 3 Existing Level of Service 2024</u> and F<u>DOT District 3 Future Level of Service 2045</u>. The Performance Measures Tracking (Appendix C) is also updated annually as part of the CMPP minor update.

WHEREAS, the Congestion Management Process Plan (CMPP) is considered a fully operational management system plan; and

WHEREAS, the purpose of the CMPP is to rate the performance of transportation facilities and suggest low-cost and short-term strategies to alleviate congestion; and

WHEREAS, the CMPP requires an annual minor update which entails evaluating performance measures and level of service (LOS) ratings for all segments of the CMPP network;

NOW, THEREFORE, BE IT RESOLVED BY THE OKALOOSA-WALTON TRANSPORTATION PLANNING ORGANIZATION THAT:

The 2025 Congestion Management Process Plan minor update is hereby adopted.

BACKGROUND: The Intergovernmental Coordination and Review and Public Transportation Coordination Joint Participation Agreement (ICAR) prescribes the process for coordination of the TPO planning activities with the Emerald Coast Regional Council (ECRC), local government comprehensive plans and operators of publicly owned transportation systems. INTERGOVERNMENTAL COORDINATION AND REVIEW AND

PUBLIC TRANSPORTATION COLLABORATIVE PLANNING AGREEMENT

THIS INTERGOVERNMENTAL COORDINATION AND REVIEW AND PUBLIC TRANSPORTATION COLLABORATIVE PLANNING AGREEMENT is made and entered into on this 20th day of November, 2025, by and between the FLORIDA DEPARTMENT OF TRANSPORTATION (Department); the OKALOOSA-WALTON TRANSPORTATION PLANNING ORGANIZATION; the EMERALD COAST REGIONAL COUNCIL; OKALOOSA COUNTY, owner and operator of the DESTINFORT WALTON BEACH AIRPORT, DESTIN EXECUTIVE AIRPORT, and BOB SIKES AIRPORT, and the owner and operator of the OKALOOSA COUNTY PUBLIC TRANSIT SYSTEM; the CITY OF DEFUNIAK SPRINGS, owner and operator of DEFUNIAK SPRINGS MUNICIPAL AIRPORT; and WALTON COUNTY; collectively referred to as the Parties.

RECITALS

WHEREAS, the Federal Government, under the authority of 23 United States Code (USC) § 134 and 49 USC § 5303 and any subsequent applicable amendments, requires each metropolitan area, as a condition to the receipt of federal capital or operating assistance, to have a continuing, cooperative, and comprehensive transportation planning process in designated urbanized areas to develop and implement plans and programs consistent with the comprehensively planned development of the metropolitan area;

WHEREAS, 23 USC § 134, 49 USC § 5303, and Section 339.175, Florida Statutes (F.S.), provide for the creation of metropolitan planning organizations to develop transportation plans and programs for urbanized areas;

WHEREAS, 23 Code of Federal Regulations (CFR) § 450 requires that the State, the Metropolitan Planning Organization, and the operators of publicly owned transportation systems shall enter into an agreement clearly identifying the responsibilities for cooperatively carrying out such transportation planning (including multimodal, systems-level corridor and subarea planning studies pursuant to 23 CFR § 450) and programming;

WHEREAS, pursuant to Section 20.23, F.S., the Department has been created by the State of Florida, and the Department has the powers and duties relating to transportation, as outlined in Section 334.044, F.S.;

WHEREAS, pursuant to 23 USC § 134, 49 USC § 5303, 23 CFR § 450, and Section 339.175 F.S., the Okaloosa-Walton Transportation Planning Organization, herein after referred to as the MPO, has been designated and its membership apportioned by the Governor of the State of Florida, with the agreement of the affected units of general purpose local government, to organize and establish the Metropolitan Planning Organization;

WHEREAS, pursuant to Section 339.175 F.S., the MPO shall execute and maintain an agreement with the metropolitan and regional intergovernmental coordination and review agencies serving the Metropolitan Planning Area;

WHEREAS, the agreement must describe the means by which activities will be coordinated and specify how transportation planning and programming will be part of the comprehensively planned development of the Metropolitan Planning Area;

WHEREAS, pursuant to Section 186.505, F.S., the RPC is to review plans of metropolitan planning organizations to identify inconsistencies between those agencies' plans and applicable local government comprehensive plans adopted pursuant to Chapter 163, F.S.;

WHEREAS, the RPC, pursuant to Section 186.507, F.S., is required to prepare a Strategic Regional Policy Plan, which will contain regional goals and policies that address regional transportation issues;

WHEREAS, based on the RPC statutory mandate to identify inconsistencies between plans of metropolitan planning organizations and applicable local government comprehensive plans, and to prepare and adopt a Strategic Regional Policy Plan, the RPC is appropriately situated to assist in the intergovernmental coordination of the transportation planning process;

WHEREAS, pursuant to Section 186.509, F.S., the RPC has adopted a conflict and dispute resolution process;

WHEREAS, the purpose of the dispute resolution process is to reconcile differences in planning and growth management issues between local governments, regional agencies, and private interests;

WHEREAS, the Parties hereto have determined that the voluntary dispute resolution process can be useful in resolving conflicts and disputes arising in the transportation planning process;

WHEREAS, pursuant to 23 CFR § 450 and Section 339.175, F.S., the MPO must execute and maintain an agreement with the operators of public transportation systems, including transit systems, commuter rail systems, airports, seaports, and spaceports, describing the means by which activities will be coordinated and specifying how public transit, commuter rail, aviation, and seaport planning (including multimodal, systems-level corridor and subarea planning studies pursuant to 23 CFR § 450) and programming will be part of the comprehensively planned development of the Metropolitan Planning Area;

WHEREAS, it is in the public interest that the MPO, operators of public transportation systems, including transit systems, commuter rail systems, port and aviation authorities, jointly pledge their intention to cooperatively participate in the planning and programming of transportation improvements within this Metropolitan Planning Area;

WHEREAS, the Intergovernmental Coordination and Review and Public Transportation Coordination Joint Participation Agreement, dated <u>April 15, 2010</u>, is hereby replaced and superseded in its entirety by this Agreement.

WHEREAS, the undersigned Parties have determined that this Agreement satisfies the requirements of and is consistent with 23 CFR § 450 and Section 339.175, F.S.; and

WHEREAS, the Parties to this Agreement desire to participate cooperatively in the performance, on a continuing basis, of a cooperative, and comprehensive transportation planning process to assure that highway facilities, transit systems, bicycle and pedestrian facilities, rail systems, air transportation, and other facilities will be located and developed in relation to the overall plan of community development.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and representation herein, the Parties desiring to be legally bound, do agree as follows:

ARTICLE 1 RECITALS AND DEFINITIONS

- 1.01. <u>Recitals.</u> Each and all of the foregoing recitals are incorporated herein and acknowledged to be true and correct. Failure of any of the foregoing recitals to be true and correct shall not operate to invalidate this Agreement.
- 1.02. <u>Definitions.</u> The following words when used in this Agreement (unless the context shall clearly indicate the contrary) shall have the following meanings:
 - (a) **Agreement** means this instrument, as may be amended from time to time.
 - (b) **Corridor or Subarea Study** means studies involving major investment decisions or as otherwise identified in 23 CFR § 450.
 - (c) **Department** means the Florida Department of Transportation, an agency of the State of Florida, created pursuant to Section 20.23, F.S.
 - (d) **FHWA** means the Federal Highway Administration.
 - (e) Long Range Transportation Plan (LRTP) means the 20-year transportation planning horizon which identifies transportation facilities; includes a financial plan that demonstrates how the plan can be implemented and assesses capital improvements necessary to preserve the existing metropolitan transportation system and make efficient use of existing transportation facilities; indicates proposed transportation activities; and, in ozone/carbon monoxide nonattainment areas is coordinated with the State Implementation Plan, all as required by 23 USC § 134, 49 USC § 5303, 23 CFR § 450, and Section 339.175, F.S.
 - (f) **Metropolitan Planning Area** means the planning area as determined by agreement between the MPO and the Governor for the urbanized areas designated by the United States Bureau of the Census as described in 23 USC § 134, 49 USC § 5303, and Section 339.175, F.S., and including the existing urbanized area and the contiguous area expected to become urbanized within a 20-year forecast period, which shall be subject to the Metropolitan Planning Organization's planning authority.
 - (g) **Metropolitan Planning Organization (MPO)** means the Okaloosa-Walton TPO formed pursuant to Interlocal Agreement as described in 23 USC § 134, 49 USC § 5303, and Section 339.175, F.S. This may also be referred to as a Transportation Planning Organization (TPO).
 - (h) **Regional Planning Council (RPC)** means the Emerald Coast Regional Council created pursuant to Section 186.504, F.S., and identified in Rule 29A, F.A.C.
 - (i) **Transportation Improvement Program (TIP)** means the staged multi-year program of transportation improvement projects developed by a Metropolitan Planning Oorganization consistent with the Long Range Transportation Plan, developed pursuant to 23 USC §§ 134 and 450, 49 USC § 5303, and Section 339.175, F.S.
 - (j) **Unified Planning Work Program (UPWP)** means a biennial program developed in cooperation with the Department and public transportation providers, that identifies the

planning priorities and activities to be carried out within a metropolitan planning area to be undertaken during a 2-year period, together with a complete description thereof and an estimated budget, as required by 23 CFR § 450.308(c), and Section 339.175, F.S.

ARTICLE 2 PURPOSE

- 2.01. <u>Coordination with public transportation system operators</u>. This Agreement is to provide for cooperation between the Parties in the development and preparation of the UPWP, the TIP, the LRTP, and any applicable Corridor or Subarea Studies.
- 2.02. <u>Intergovernmental coordination; Regional Planning Council</u>. Further, this Agreement is to provide a process through the RPC for intergovernmental coordination and review and identification of inconsistencies between proposed MPO transportation plans and local government comprehensive plans adopted pursuant to Chapter 163, F.S., and reviewed by the Division of Community Development within the Florida Department of Economic Opportunity.
- 2.03. <u>Dispute resolution</u>. This Agreement also provides a process for conflict and dispute resolution through the RPC.

ARTICLE 3 COOPERATIVE PROCEDURES FOR PLANNING AND PROGRAMMING WITH OPERATORS OF PUBLIC TRANSPORTATION SYSTEMS

- 3.01. <u>Cooperation with operators of public transportation systems; coordination with local government approved comprehensive plans</u>.
 - (a) The MPO shall cooperate with the OKALOOSA COUNTY, owner and operator of the DESTIN-FORT WALTON BEACH AIRPORT, DESTIN EXECUTIVE AIRPORT, and BOB SIKES AIRPORT, and the owner and operator of the OKALOOSA COUNTY PUBLIC TRANSIT SYSTEM; the CITY OF DEFUNIAK SPRINGS, owner and operator of DEFUNIAK SPRINGS MUNICIPAL AIRPORT; and WALTON COUNTY (collectively, "Transportation Authorities"] to optimize the planning and programming of an integrated and balanced intermodal transportation system for the Metropolitan Planning Area.
 - (b) The MPO shall implement a continuing, cooperative, and comprehensive transportation planning process that is consistent, to the maximum extent feasible, with port and aviation master plans, and public transit development plans of the units of local governments whose boundaries are within the Metropolitan Planning Area.
 - (c) As a means towards achievement of the goals in paragraphs (a) and (b) and in an effort to coordinate intermodal transportation planning and programming, the MPO may include, but shall include if within a transportation management area, as part of its membership officials of agencies that administer or operate major modes or systems of transportation, including but not limited to transit operators, sponsors of major local airports, maritime ports, and rail operators per Federal regulations. The representatives of the major modes or systems of transportation may be accorded voting or non-voting advisor status. In the Metropolitan Planning Area if authorities or agencies are created by law to perform transportation functions and are not under the jurisdiction of a general purpose local government represented on the MPO, the MPO

may request the Governor to designate said authority or agency as a voting member of the MPO in accordance with the requirements of Section 339.175, F.S. If the new member would significantly alter local government representation in the MPO, the MPO shall propose a revised apportionment plan to the Governor to ensure voting membership on the MPO to be an elected official representing public transit authorities which have been, or may be, created by law.

The MPO shall ensure that representatives of ports, transit authorities, rail authorities, and airports within the Metropolitan Planning Area are provided membership on the MPO Technical Advisory Committee.

3.02. <u>Preparation of transportation related plans</u>.

- (a) Although the adoption or approval of the UPWP, the TIP, and the LRTP is the responsibility of the MPO, development of such plans or programs shall be viewed as a cooperative effort involving the Parties to this Agreement. In developing its plans and programs, the MPO shall solicit the comments and recommendations of the other Parties to this Agreement in the preparation of such plans and programs.
- (b) When preparing the UPWP, the TIP, or the LRTP, or preparing other than a minor amendment thereto (as determined by the MPO), the MPO shall provide notice to all other Parties to this Agreement to advise them of the scope of the work to be undertaken and inviting comment and participation in the development process. The MPO shall ensure that the chief operating officials of the other Parties receive written notice at least 15 days prior to the date of all public workshops and hearings, or within the specified number of days per MPO bylaws or public participation plan, relating to the development of such plans and programs.
- (c) Local government comprehensive plans.
 - (1) In developing the TIP, the LRTP, or Corridor or Subarea studies, or preparing other than a minor amendment thereto (as determined by the MPO), the MPO and Transportation Authorities shall review for consistency for each local government in the Metropolitan Planning Area:
 - (i) each comprehensive plan's future land use element;
 - (ii) the goals, objectives, and policies of each comprehensive plan; and
 - (iii) the zoning, of each local government in the Metropolitan Planning Area.
 - (2) Based upon the foregoing review and in consideration of other relevant growth management plans, the MPO and Transportation Authorities shall provide written recommendations to local governments in the Metropolitan Planning Area in the development, amendment, and implementation of their comprehensive plans. A copy of the recommendations shall be sent to the RPC.
 - (3) The MPO agrees that, to the maximum extent feasible, the LRTP and the projects and project-phases within the TIP shall be consistent with the future land use element and the goals, objectives, and policies of each comprehensive plan of the local governments in the Metropolitan Planning Area. If the MPO's TIP is inconsistent with a local government's comprehensive plan, the MPO shall so

indicate, and the MPO shall present, as part of the TIP, justification for including the project in the program.

- (d) Multi-modal transportation agency plans.
 - (1) In developing the TIP, the LRTP, or Corridor or Subarea studies, or preparing other than a minor amendment thereto (as determined by the MPO), the MPO shall analyze the master plans of the Transportation Authorities. Based upon the foregoing review and a consideration of other transportation related factors, the MPO, shall from time to time and as appropriate, provide recommendations to the other Parties to this Agreement as well as local governments within the Metropolitan Planning Area, for the development, amendment, and implementation of their master, development, or comprehensive plans.
 - (2) In developing or revising their respective master, development, or comprehensive plans, the Parties to this Agreement shall analyze the draft or approved UPWP, TIP, LRTP, or Corridor or Subarea studies, or amendments thereto. Based upon the foregoing review and a consideration of other transportation related factors, the Parties to this Agreement shall as appropriate, provide written recommendations to the MPO with regard to development, amendment, and implementation of the plans, programs, and studies.
 - (3) The MPO agrees that, to the maximum extent feasible, the TIP shall be consistent with the affected growth management and other relevant plans of the other Parties to this Agreement.

ARTICLE 4 INTERGOVERNMENTAL COORDINATION AND REVIEW

- 4.01. <u>Coordination with Regional Planning Council</u>. The RPC shall do the following:
 - (a) Within 30 days of receipt, the RPC shall review the draft TIP, LRTP, Corridor and Subarea studies, or amendments thereto, as requested by the MPO, to identify inconsistencies between these plans and programs and applicable local government comprehensive plans adopted pursuant to Chapter 163, F.S., for counties and cities within the Metropolitan Planning Area and the adopted Strategic Regional Policy Plan.
 - (1) The Parties recognize that, pursuant to Florida law, the LRTP and the TIP of the MPO must be considered by cities and counties within the Metropolitan Planning Area in the preparation, amendment, and update/revision of their comprehensive plans. Further, the LRTP and the projects and project phases within the TIP are to be consistent with the future land use element and goals, objectives, and policies of the comprehensive plans of local governments in the Metropolitan Planning Area. Upon completion of its review of a draft TIP or LRTP, the RPC shall advise the MPO and each county or city of its findings;
 - (2) The RPC shall advise the MPO in writing of its concerns and identify those portions of the submittals which need to be reevaluated and potentially modified if the RPC review identifies inconsistencies between the draft TIP or LRTP and local comprehensive plans; and

- (3) Upon final adoption of the proposed TIP, LRTP, Corridor and Subarea studies, or amendments thereto, the MPO may request that the RPC consider adoption of regional transportation goals, objectives, and policies in the Strategic Regional Policy Plan implementing the adopted TIP, LRTP, Corridor and Subarea studies, or amendments thereto. If the proposed plan, program, or study, or amendments thereto, was the subject of previous adverse comment by the RPC, the MPO will identify the change in the final adopted plan intended to resolve the adverse comment, or alternatively, the MPO shall identify the reason for not amending the plan as suggested by the RPC.
- (b) Provide the availability of the conflict and dispute resolution process as set forth in Article 5 of this Agreement.

ARTICLE 5 CONFLICT AND DISPUTE RESOLUTION PROCESS

- 5.01. <u>Disputes and conflicts under this Agreement</u>. This process shall apply to conflicts and disputes relating to matters subject to this Agreement, or conflicts arising from the performance of this Agreement. Except as otherwise provided in this Article 5, only representatives of a party to this Agreement with conflicts or disputes shall engage in conflict resolution.
- 5.02. <u>Initial resolution</u>. The affected parties to this Agreement shall, at a minimum, ensure the attempted early resolution of conflicts relating to such matters. Early resolution shall be handled by direct discussion between the following officials:

Department: District Director for Planning and Programs

MPO: The current TPO Chair

RPC: The current Chief Executive Officer

Okaloosa County Transit System: The current Manager

Okaloosa County Airports Department: The current Airport Director

DeFuniak Springs Municipal Airport: The current Airport Manager

Walton County Board of Commissioners: The current Board of Commissioners

- 5.03. <u>Resolution by senior agency official</u>. If the conflict remains unresolved, the conflict shall be resolved by the officials listed on section 5.02 of this Agreement, with the exception of the Department's listed official, which for purposes of this section 5.03 shall be the District Secretary.
- 5.04. Resolution by the Office of the Governor. If the conflict is not resolved through conflict resolution pursuant to sections 5.01, 5.02, and 5.03 of this Agreement, the affected parties shall petition the Executive Office of the Governor for resolution of the conflict pursuant to its procedures. Resolution of the conflict by the Executive Office of the Governor shall be binding on the affected parties.

MISCELLANEOUS PROVISION

- 6.01. <u>Constitutional or statutory duties and responsibilities of parties</u>. This Agreement shall not be construed to authorize the delegation of the constitutional or statutory duties of any of the Parties. In addition, this Agreement does not relieve any of the Parties of an obligation or responsibility imposed upon them by law, except to the extent of actual and timely performance thereof by one or more of the Parties to this Agreement or any legal or administrative entity created or authorized by this Agreement, in which case this performance may be offered in satisfaction of the obligation or responsibility.
- 6.02. <u>Amendment of Agreement</u>. Amendments or modifications of this Agreement may only be made by written agreement signed by all Parties hereto with the same formalities as the original Agreement.
- 6.03. <u>Duration; withdrawal procedure</u>.
 - (a) <u>Duration</u>. This Agreement shall have a term of five (5) years and the Parties hereto shall examine the terms hereof and agree to amend the provisions or reaffirm the same in a timely manner. However, the failure to amend or to reaffirm the terms of this Agreement shall not invalidate or otherwise terminate this Agreement.
 - (b) <u>Withdrawal procedure</u>. With the exception of the MPO, any party to this Agreement may withdraw after presenting in written form a notice of intent to withdraw to the other Parties to this Agreement, at least ninety (90) days prior to the intended date of withdrawal; provided, that financial commitments made prior to withdrawal are effective and binding for their full term and amount regardless of withdrawal.
- 6.04. <u>Notices</u>. All notices, demands and correspondence required or provided for under this Agreement shall be in writing and delivered in person or dispatched by certified mail, postage prepaid, return receipt requested, to the officials identified for each party in section 5.02 of this agreement.

A party may unilaterally change its address or addressee by giving notice in writing to the other Parties as provided in this section. Thereafter, notices, demands and other pertinent correspondence shall be addressed and transmitted to the new address.

6.05. Interpretation.

- (a) <u>Drafters of Agreement</u>. All Parties to this Agreement were each represented by, or afforded the opportunity for representation by legal counsel, and participated in the drafting of this Agreement and in the choice of wording. Consequently, no provision hereof should be more strongly construed against any party as drafter of this Agreement.
- (b) <u>Severability</u>. Invalidation of any one of the provisions of this Agreement or any part, clause or word hereof, or the application thereof in specific circumstances, by judgment, court order, or administrative hearing or order shall not affect any other provisions or applications in other circumstances, all of which shall remain in full force and effect; provided, that such remainder would then continue to conform to the terms and requirements of applicable law.

- (c) Rules of construction. In interpreting this Agreement, the following rules of construction shall apply unless the context indicates otherwise:
 - The singular of any word or term includes the plural;
 - (2) The masculine gender includes the feminine gender; and
 - (3) The word "shall" is mandatory, and "may" is permissive.
- 6.06. <u>Attorney's Fees</u>. In the event of any judicial or administrative action to enforce or interpret this Agreement by any party hereto, each party shall bear its own costs and attorney's fees in connection with such proceeding.
- 6.07. <u>Agreement execution; use of counterpart signature pages</u>. This Agreement, and any amendments hereto, may be simultaneously executed in several counterparts, each of which so executed shall be deemed to be an original, and such counterparts together shall constitute one and the same instrument.
- 6.08. <u>Effective date</u>. This Agreement shall become effective on the date last signed by the Parties hereto.
- 6.09. Other authority. In the event that any election, referendum, approval, permit, notice, or other proceeding or authorization is required under applicable law to enable the Parties to enter into this Agreement or to undertake the provisions set forth hereunder, or to observe, assume or carry out any of the provisions of the Agreement, said Parties will initiate and consummate, as provided by law, all actions necessary with respect to any such matters as required.
- 6.10. <u>Parties not obligated to third parties</u>. No party hereto shall be obligated or be liable hereunder to any party not a signatory to this Agreement. There are no express or intended third-party beneficiaries to this Agreement.
- 6.11. Rights and remedies not waived. In no event shall the making by the Department of any payment to the MPO constitute or be construed as a waiver by the Department of any breach of covenant or any default which may then exist on the part of the MPO, and the making of any such payment by the Department while any such breach or default exists shall in no way impair or prejudice any right or remedy available to the Department in respect of such breach or default.
- 6.12 <u>Data, records, reports and other documents.</u> Subject to the right to claim an exemption from the Florida Public Records Law, Chapter 119, F.S., the Parties, excluding the Department, shall provide to each other such data, reports, records, contracts, and other documents in its possession relating to the MPO as is requested. Charges are to be in accordance with Chapter 119, F.S.



Gary Kramer explained the TIP's role in the process of development of transportation projects from conception to construction, then noted that the complete draft plan, along with comments received during the public input period, were sent to the committee members earlier in the month.

Tim Gibson moved to recommend the TPO authorize the TPO chair to sign Resolution O-W 25-03 adopting the Okaloosa-Walton TPO FY 2026-2030 Transportation Improvement Program. Chance Powell seconded the motion, and it was unanimously approved.

4. ENCLOSURE D - ALL COMMITTEES - Consideration of Resolution O-W 25-04 Adopting the Okaloosa-Walton TPO FY 2027 – FY 2031 Project Priorities

Jill Nobles provided a PowerPoint presentation and explained the project priorities development cycle and where it fits into the overall development of transportation projects from concept to construction. Jill Nobles then explained the types of projects in the priorities and highlighted public comments that were received, specifically

changes that were requested by local governments. There was a lot of support for moving the Around the Mound and the PJ Adams Pkwy. /Antioch Rd. at Crab Apple Avenue intersection realignment and signalization project up in the ranking.

Rae Emary provided further information on the public feedback that was received, including an impressive 421 completed surveys. Tourist impacts, school start and stop times, as well as congestion, specifically during peak hours, were the main areas of commute frustration that were reported. Construction zone delays were not listed very high. Most survey takers gave comments and many of them were about congestion on US 98 and SR 85, needed signal timing improvements, more and safer bicycle and pedestrian facilities, and the need for alternative routes.

Kristen Shell asked what methods were used to get that level of input. Rae Emary said there were several. Staff created a convenient media kit and distributed it to area stakeholders and agencies who were able to help spread the survey throughout the TPO's geographical area. Staff also used social media and went out into the community.

Jill Nobles provided the CAC's recommendations, which included the following changes: Move the SIS Priority #4 to #2, move the Non-SIS Priority #12 up in priority, at the TPO's discretion, and move the TSM Priority #9 up in priority, also at the TPO's discretion.

Jill Nobles also noted that staff just received the DeFuniak Springs Airport's priorities and asked that any motion include recommending the TPO accept and include those into the Project Priorities.

Chris Wallace expressed concern about moving #12 up because it could adversely affect the ranking of projects in Walton County. Chair Hughes–Neel agreed with this concern and suggested recommending the TPO ask its Okaloosa County members which of their projects in the top eleven they would like to swap with #12.

Scott Davidson spoke to the mission critical need of the US 98 widening project and asked that the TCC leave it as #1 in their recommendation to the TPO.

Chris Wallace moved to recommend that the TPO add the Perry Avenue one-way study to the Non-SIS Priority #2, Transportation Planning Studies, to keep the current SIS Priority #1,US 98 in the #1 position, to incorporate the DeFuniak Springs Airport priorities as submitted, and if changing the priority of any SIS projects, that such changes should only have an impact on projects within the same county. Joel Paul seconded the motion, and it was unanimously approved.

Christy Johnson explained both requested amendments and noted that the right-ofway phase for the SR 85 project is being advanced due to it being donated. The project is being completed through a LAP agreement.

Don Cleveland noted that the name of the road referenced in Enclosure A is Live Oak Church Road and asked that this be corrected on all documentation. Staff agreed.

Mike Panarisi moved to recommend the TPO authorize the TPO chair to sign Resolution O-W 25-08 and Resolution O-W 25-09 amending the FY 2025-2029 Transportation Improvement Program. Yvonne Earle seconded the motion, and it was unanimously approved.

3. ENCLOSURE C - ALL COMMITTEES - ROLL CALL VOTE AND PUBLIC HEARING - Consideration of Resolution O-W 25-03 Adopting the Okaloosa-Walton TPO FY 2026-2030 Transportation Improvement Program (TIP)

Gary Kramer explained the TIP's role in the process of development of transportation projects from conception to construction, then noted that the complete draft plan, along with comments received during the public input period, were sent to the committee members earlier in the month.

Michelle Kitch moved to recommend the TPO authorize the TPO chair to sign Resolution O-W 25-03 adopting the Okaloosa-Walton TPO FY 2026-2030 Transportation Improvement Program. Don Cleveland seconded the motion, and it was unanimously approved.

4. ENCLOSURE D - ALL COMMITTEES - Consideration of Resolution O-W 25-04 Adopting the Okaloosa-Walton TPO FY 2027 – FY 2031 Project Priorities

Jill Nobles provided a PowerPoint presentation and explained the project priorities development cycle and where it fits into the overall development of transportation projects from concept to construction. Jill Nobles then explained the types of projects in the priorities and highlighted public comments that were received, specifically changes that were requested by local governments. There was a lot of support for moving the Around the Mound and the PJ Adams Pkwy./Antioch Rd. at Crab Apple Avenue intersection realignment and signalization project up in the ranking.

Rae Emary provided further information on the public feedback that was received, including an impressive 421 completed surveys. Tourist impacts, school start and stop times, as well as congestion, specifically during peak hours, were the main areas of commute frustration that were reported. Construction zone delays were not listed very high. Most survey takers gave comments and many of them were about congestion on US 98 and SR 85, needed signal timing improvements, more and safer bicycle and pedestrian facilities, and the need for alternative routes.

Yvonne Earle asked that Around the Mound project be coordinated with the Brooks Bridge improvement and asked that this concern be brought to the TPO.

Yvonne Shanklin asked if the PJ Adams intersection project is being coordinated to align the misaligned road in the area. Mayor Whitten, attending online, agreed with the need to incorporate this project, a major obstacle being that one project is a local project, and the other is an FDOT project. Another obstacle being that FDOT cannot install a traffic signal because the configuration is not a four-way stop.

Christy Johnson said it is an issue of federal approval to construct an interchange at I-10 and Antioch Road. There was general discussion about the need to align Antioch Road with Crab Apple Avenue for the signal installation in order to avoid safety hazards.

The concern for both the Around the Mound/Brooks Bridge and the PJ Adams/Crab Apple/Antioch Road areas was the need for coordination of work in those corridors to avoid prolonged disruptions to the traffic, residents, and businesses there.

There was much discussion about where to recommend the TPO place projects related to Non-SIS Priority #12 (PJ Adams/Antioch at Crab Apple) and SIS Priority #4 (Around the Mound) in the Priorities.

Yvonne Earle moved to recommend the TPO move SIS Priority #4 to #2. The motion was seconded by Don Cleveland and it was unanimously approved.

There was then discussion about the Non-SIS Priority #12 project and what the concerns are regarding safety improvement needs there. There was also discussion about what the CAC should request the TPO to do with the ranking of this project.

Yvonne Shanklin moved to recommend the TPO move the current #12 Non-SIS project higher in priority, at the TPO's discretion. Mike Panarisi seconded the motion, and it was unanimously approved.

Yvonne Earle noted that there is tremendous need for the listed #9 TSM project, the SR 189/Poquito Road intersection traffic signal.

Yvonne Earle moved to recommend the TPO move the current #9 TSM Priority, SR 189 at Poquito Road, higher in priority, at the TPO's discretion. Don Cleveland seconded the motion, and it was unanimously approved.

Mike Panarisi moved to recommend the TPO authorize the TPO chair to sign Resolution O-W 25-04 adopting the Okaloosa-Walton TPO FY 2027-2031 Project Priorities with the above recommended changes. Yvonne Shanklin seconded the motion, and it was unanimously approved.

Yvonne Shanklin moved to recommend the TPO authorize the TPO chair to sign Resolution O-W 25-05 approving the scope of services for the Okaloosa-Walton TPO 2050 Long Range Transportation Plan update and appointment of Michelle Kitch, Robert Rennie, and Yvonne Shanklin to the steering committee. Mike Panarisi seconded the motion, and it was unanimously approved.

6. ENCLOSURE F - ALL COMMITTEES – Nomination and Election of TPO Board, TCC, and CAC Chair and Vice Chair for FY 2026

Tiffany Bates asked for volunteers to serve as chair and vice chair for the next fiscal year.

Yvonne Earle moved to elect Amy Jamieson to serve as CAC chair for FY 2026, and Robert Rennie to serve as vice chair. Michelle Kitch seconded the motion, and it was unanimously approved.

OTHER BUSINESS

Don Cleveland announced that he must resign from CAC due to health issues. Chair Jamieson, the other committee members, and staff thanked Mr. Cleveland for his many years of service to the TPO.

Michelle Kitch said the CAC asked for warning signage at the hill at US90 and U331 and it has not happened. Accidents continue to occur. Christy Johnson said the contractor was asked to put the signage in and sent an email to the FDOT contact to reiterate it.

Michelle Kitch said the No U turn sign at the Lowe's in DeFuniak Springs was pulled out of median and this is causing a safety hazard due to the blind spot. Christie Johnson made note of it and agreed to ask that it be replaced.

Michelle Kitch noted there are new traffic lights coming into DeFuniak Springs along Hwy 90 and stated that the Hwy 90 corridor through the city is extremely congested already. She asked if signal timing will be such that it does not make the stop and go

nature of the traffic worse. Yvonne Earle suggested contacting the Walton County Traffic Engineer, and Michelle Kitch agreed.




