**SUBJECT:** Presentation on Sorrento Road Safety Study

**ORIGIN OF SUBJECT:** Florida-Alabama TPO

FDOT Traffic Operations contacted TPO staff to begin developing a stakeholder list and announced they would be studying the corridor as requested. Currently, the study is underway and preliminary results will be presented to the TPO board and stakeholders.

**CALL TO ORDER/INVOCATION/PLEDGE/BOARD MEMBER ROLL CALL**

Commissioner Smith proceeded as chair in the absence of Commissioner Barry. Vice Chair Smith called the meeting to order. Commissioner Burkett delivered the invocation, and

Commissioner Kohler led the Pledge of Allegiance. Tiffany Bates conducted a roll call and confirmed a quorum was present.

## **APPROVAL OF AGENDA**

**Commissioner Gruber moved to approve the agenda. The motion was seconded by Commissioner Wright, and it was unanimously approved.**

## **PUBLIC FORUM**

Kandase Lee introduced Curtis McBride, Chief Executive Officer of Myovision, noting the company's longstanding partnership with Escambia County, Santa Rosa County, and the Florida-Alabama TPO.

Curtis McBride provided a presentation on Myovision's history and its early deployment in Escambia County, describing the company's first intersection installations and the role those projects played in national expansion. Curtis McBride discussed several transportation technology applications currently deployed nationwide, including continuous safety analytics using video-based detection, connected vehicle alerts that communicate pedestrian and cyclist presence directly to in-vehicle dashboards, emergency vehicle preemption systems, and transit signal priority. Examples were shared demonstrating how near-miss data can be used to proactively identify safety risks and implement countermeasures before crashes occur. Curtis McBride also highlighted Myovision's partnerships with automotive manufacturers, mapping providers, and data visualization platforms, emphasizing open data integration through application programming interfaces.

Curtis McBride concluded by discussing Myovision's automated traffic engineering platform, Mateo, which allows staff to interact conversationally with system data to diagnose and resolve traffic issues more efficiently. A demonstration vehicle was made available outside the meeting venue for members interested in viewing connected vehicle applications in real-time.

Chair Barry arrived late due to a traffic delay and assumed the chair, thanking Vice Chair Smith for starting the meeting and thanking Curtis McBride for the presentation. No questions were raised from board members.

## **FDOT/ALDOT UPDATES**

Bryant Paulk provided an update, and two upcoming project information meetings were announced. A virtual public meeting will be held beginning November 20 for a resurfacing project on State Road 87 in Santa Rosa County from U.S. 90 north to Clear Creek, including the construction of a new signalized intersection at Magnolia Street. A second project update involves improvements at the Davis Highway and Scenic Highway intersection in Escambia

County, including added left turn lanes for westbound and southbound movements. A hybrid public meeting is scheduled for January 29 at the Upward Church Fellowship Hall with a virtual option available through the Northwest Florida Roads website.

Chair Barry asked for an update on Interstate 10 projects at U.S. 90 and U.S. 29. Bryant Paulk stated there is no confirmed information indicating delays or removals from the current work program, though statewide Strategic Intermodal System funding changes may affect scheduling across corridors. Bryant Paulk confirmed both projects are currently programmed to move forward.

Council Member Bare raised questions regarding ramp operations along Interstate 110 at Brent Lane near Baptist Hospital, suggesting potential striping or lane-use adjustments to reduce congestion. Bryant Paulk indicated the comments would be forwarded to FDOT traffic operations staff for review. Additional concerns were raised regarding traffic backups near the Cervantes Street exit from I-110. Bryant Paulk acknowledged the operational challenges and stated the location would be evaluated.

**ALDOT Update – Vincent Beebe, P.E., ALDOT**

Vincent Beebe provided an update and stated that construction continues on the Foley Beach Express to State Route 180 project, including bridge work over the Intracoastal Waterway. Completion is anticipated by the end of the summer of next year. Vincent Beebe also noted ongoing evaluation of alternatives at the State Route 180 and State Route 161 intersection, with public involvement anticipated mid-year. Pedestrian crossing improvements are underway along State Route 182, and Baldwin County is coordinating with ALDOT on a signal installation at U.S. 98 and County Road 91.

**2. ENCLOSURE B – ALL COMMITTEES – Consideration of Resolution FL-AL 25-26 Accepting the FDOT FY 2027-2031 Tentative Work Program – *Bryant Paulk, AICP, FDOT/ Carla Hodges, FDOT***

Carla Hodges provided a detailed overview of the FDOT FY 2027–2031 Tentative Work Program for District Three. The presentation summarized overall district funding levels, investment breakdowns, and cost trends related to materials and workforce conditions. Carla Hodges highlighted major Strategic Intermodal System priorities, including Interstate 10 widening projects, interchange improvements at State Road 99, and ongoing design activities. Non-SIS priorities included extensive ITS fiber deployment across Escambia and Santa Rosa counties, transportation systems management projects, transportation alternatives projects, aviation and seaport investments, and resurfacing initiatives. Carla Hodges emphasized continued coordination with the TPO to ensure alignment with adopted priorities.

**Commissioner May moved to authorize the TPO chair to sign Resolution FL AL 25-26 accepting the FDOT FY 2027-2031 Tentative Work Program. Council Member Patton seconded the motion, and it was unanimously approved.**

**3. ENCLOSURE C – ALL COMMITTEES – Consideration of Resolution FL-AL 25-27 Adopting Statewide Targets for Safety Performance Measures – *Gary Kramer, ECRC Staff***

Gary Kramer presented Resolution FL-AL 25-27 adopting statewide safety performance targets. The resolution continues the practice of supporting FDOT's Target Zero initiative and ALDOT's Toward Zero Deaths initiative. The presentation explained federal safety performance requirements and the methodology used by both states.

**Council Member Bare moved to authorize the TPO chair to sign Resolution FL-AL 25-27 adopting statewide targets for safety performance measures Commissioner Burkett seconded the motion, and it was unanimously approved.**

Jill Nobles presented a minor update to the Congestion Management Process Plan. The update reflects current level-of-service data, performance measures, and corridor management practices. Jill Nobles noted that adoption of the full plan update would be requested at a future meeting.

**WHEREAS**, the Florida-Alabama Transportation Planning Organization (TPO) is the organization designated by the governors of Florida and Alabama as being responsible, together with the States of Florida and Alabama, for carrying out the continuing, cooperative and comprehensive transportation planning process for the Florida-Alabama TPO planning area; and

**WHEREAS**, the Transportation Improvement Program (TIP) is adopted annually by the TPO and submitted to the governor of the State of Florida and the governor of the State of Alabama, to the Federal Transit Administration (FTA), and through the State of Alabama and State of Florida to the Federal Highway Administration (FHWA); and

**WHEREAS**, the TIP is periodically amended to maintain consistency with the Florida and Alabama Departments of Transportation Work Programs; and

**WHEREAS**, authorization for federal funding of projects within an urban area cannot be obtained unless the projects are included in the TPO's TIP; and

**WHEREAS**, the Florida-Alabama Transportation Planning Organization (TPO) believes that the amendment listed below will support the performance targets established by the states and supported by the TPO.

#### **NOW, THEREFORE, BE IT RESOLVED BY THE FLORIDA-ALABAMA TRANSPORTATION PLANNING ORGANIZATION THAT:**







**Subject: FL-AL TPO Regional Traffic Signal Operations Center Seasonal Beach Traffic Monitoring Task for 2026**

**Background:**

The Florida-Alabama Transportation Planning Organization (FL-AL TPO) has requested that DRMP, as a part of the services provided under the ongoing traffic engineering support contract with the FL-AL TPO, provide active traffic monitoring/operations on weekends and evenings for the 2026 summer tourism season. This document generally describes the anticipated services.

**Description of Work Activities:**

The requested services include monitoring traffic conditions on Pensacola Beach Road and on Navarre Beach Causeway during prescribed hours on weekends and during special events throughout the tourism season. The prescribed schedule is attached to this document. DRMP will monitor the traffic flow on the corridors via video feed and adjust signal timing as needed to improve traffic operations. All signal timing adjustments will be based on performance criteria approved by the FDOT. DRMP will provide the monitoring services at all times prescribed in the attached schedule, however, it is anticipated that there may be weather conditions or other events that cause the expected traffic volumes to be low. In this event, DRMP will seek approval from the local agency prior to ceasing monitoring activity. Services shall include active local agency communication and reporting during monitoring and provide a weekly written report of activity.

**Compensation:**

Compensation for the services will be based on actual time committed to the effort at approved contract rates. This task shall be invoiced and compensated under the terms listed in the ongoing Professional Consulting Services Contract Agreement between the FL-AL TPO and DRMP. The total estimated staff-hour to monitor the season beach traffic is approximately 898 hours. Based on an average hourly rate of \$140, the total estimated cost is **\$125,720.00** for this effort.

The FL-AL TPO is requesting compensation support from Escambia County and Santa Rosa for the 898 hours to monitor Pensacola Beach and Navarre Beach traffic as was done in 2023, 2024, and 2025. The amount requested from each agency will be based on the peak volumes of traffic recorded at each beach in the 2025 season. The amount of SB traffic counted at Pensacola Beach divided by the total amount of SB traffic at both beaches is approximately 2/3, with Navarre Beach making up the other 1/3 of the total traffic. The FL-AL TPO will split the total cost with the agencies. Based on this, the total compensation



shall be split 2/3 to Escambia County at **\$41,906.67** and 1/3 to Santa Rosa County at **\$20,953.33**. See Table 1 below for the cost share breakdown.

**WHEREAS**, the FL-AL TPO's MPA crosses the Florida-Alabama state line and includes portions of Escambia and Santa Rosa Counties, Florida, and a portion of Baldwin County, Alabama; and

**WHEREAS**, the Parties desire to memorialize roles, responsibilities, procedures, and coordination to meet Federal requirements and to reflect best practices used by multistate MPOs;

**INTERSTATE COMPACT MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE FLORIDA-  
ALABAMA TRANSPORTATION PLANNING ORGANIZATION (FL-AL TPO), THE FLORIDA  
DEPARTMENT OF TRANSPORTATION (FDOT), THE ALABAMA DEPARTMENT OF  
TRANSPORTATION (ALDOT), ESCAMBIA COUNTY AREA TRANSIT (ECAT), AND BALDWIN RURAL  
AREA TRANSPORTATION SYSTEM (BRATS)**

## **1. PURPOSE**

This Agreement establishes the framework under which the Parties shall carry out the continuing, cooperative, and comprehensive (3C) Long Range Transportation Planning and programming process for the entire multistate Metropolitan Planning Area (MPA) and is intended to satisfy 23 CFR §450.314.

## **2. SCOPE OF THE METROPOLITAN PLANNING PROCESS**

The Parties shall conduct the planning process consistent with 23 CFR §§450.306–450.340, including performance-based planning and programming, (PBPP), public participation, and, where applicable, a congestion management process (CMP) in transportation management areas (TMAs).

## **3. ROLES AND RESPONSIBILITIES**

- FL-AL TPO will lead the metropolitan planning process; adopt a Long Range Transportation Plan (LRTP) and Transportation Improvement Plan (TIP); ensure public participation consistent with the adopted Public Participation Plan (PPP); develop and adopt performance targets; and coordinate with adjacent MPOs in Florida and Alabama on any cross-boundary investments.
- FDOT and ALDOT will provide planning guidance; furnish project and program information; coordinate revenue forecasts; participate in target setting; ensure consistency of the TIP with the Statewide Transportation Improvement Programs (STIPs); and provide modeling, GIS, and technical support.
- ECAT and BRATS will participate in development of transit plans and projects; provide transit service and asset data; jointly develop financial plans and transit-related elements of the LRTP and TIP; participate in PBPP (transit safety and transit asset management) and target setting.

## **4. LONG RANGE TRANSPORTATION PLAN (LRTP)**

The Parties shall cooperatively develop and maintain a financially constrained, multimodal LRTP for the entire multistate MPA pursuant to 23 CFR §450.324. FDOT, ALDOT, ECAT, and BRATS shall provide timely data, project information, cost estimates, and revenue assumptions. Projects crossing the state line shall be planned and analyzed with common assumptions and schedule coordination.

## **5. TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

The Parties shall cooperatively develop a fiscally constrained TIP pursuant to 23 CFR §450.326 covering all federally funded and regionally significant projects in the Florida and Alabama portions of the MPA. The TIP shall be consistent with the STIPs of Florida and Alabama, and cross-border projects shall be programmed consistently in both states.

## **6. FINANCIAL PLANS**

The Parties shall cooperatively develop and share information needed for the financial plans that support the LRTP and TIP, including coordinated revenue forecasts, inflation factors, operations and maintenance costs, and project cost estimates, in accordance with 23 CFR §§450.324 and 450.326.

## **7. ANNUAL LISTING OF OBLIGATED PROJECTS (ALOP)**

Within 90 days after the close of each Federal fiscal year, the FL-AL TPO shall cooperatively develop and publish the ALOP for the entire MPA as required by 23 CFR §450.334, including transit and highway projects in both states.

## **8. DATA, MODELING, AND ASSUMPTIONS**

The Parties shall maintain consistency of datasets and assumptions used in planning analyses, including (a) socioeconomic forecasts and control totals; (b) travel demand model networks and parameters; (c) project scopes, costs, and schedules; and (d) performance measure baselines and targets. Documentation and version control shall be maintained through the UPWP.

## **9. PERFORMANCE-BASED PLANNING AND PROGRAMMING**

The Parties shall cooperatively establish, adopt, and report performance targets for highway safety, pavement and bridge condition, system performance (including freight and CMAQ, if/when applicable), transit safety, and transit asset management; and integrate those targets and assessments into the LRTP and TIP, consistent with 23 CFR §450.306 and related USDOT performance rules.

## **10. CONGESTION MANAGEMENT PROCESS**

The FL-AL TPO shall develop and maintain a congestion management process (CMP) consistent with 23 CFR §450.322, in collaboration with FDOT, ALDOT, transit providers, and local jurisdictions.

## **11. PUBLIC PARTICIPATION & CIVIL RIGHTS**

All Parties shall conduct the planning process in accordance with the FL-AL TPO's adopted Public Participation Plan and applicable civil rights requirements, including Title VI of the Civil Rights Act, Environmental Justice, LEP, ADA, and related Federal and State nondiscrimination statutes, consistent with 23 CFR §450.316.

## **12. AIR QUALITY—CONFORMITY**

Air Quality (if status changes): designate interagency consultation contacts (FL DEP, AL Department of Environmental Management, EPA Region 4) and attach conformity workflow. If Air Quality status changes, an interagency consultation group will be assembled that will consist of at least the FL-AL TPO, FL DEP, AL Department of Environmental Management, EPA Region 4, FDOT, ALDOT, FHWA, and FTA. Air quality conformity processes will be initiated, following the provisions of the Florida and Alabama State Implementation Plans (SIPs) and 40 CFR 93. An adjustment period will be identified since a SIP budget will not yet have been established by our state partners. During this adjustment period, an interim test would be used to compare future emissions to baseline values. Upon the development of a SIP budget for the region, it will need to be reflected in any Conformity Analysis for the region.

## **13. UNIFIED PLANNING WORK PROGRAM (UPWP) & FUNDING**

All planning activities shall be programmed through the UPWP pursuant to 23 CFR §450.308. FDOT and ALDOT shall make metropolitan planning (PL, 5305/CPG) funds available to the TPO in accordance with State formulas. Billing, reporting, and audits shall comply with 23 CFR part 200 and applicable State requirements.

## **14. COORDINATION WITH ADJACENT MPOS**

Where proposed transportation investments extend beyond or across the MPO or MPA boundaries, the Parties shall coordinate to ensure the development of consistent planning products, including joint assumptions, schedules, and programming actions, consistent with 23 CFR §450.314(e).

## **15. PERIODIC REVIEW AND AMENDMENT**

The Parties shall review this Agreement at least once every four (4) years and update it as necessary to reflect changes in law, regulation, MPA boundaries, organizational roles, or planning practices.

## **16. MEMBERSHIP APPORTIONMENT**

The Parties acknowledge and incorporate the FL-AL TPO membership apportionment plan adopted on August 9, 2023, confirming representation consistent with 23 CFR §450.310.

## **17. TERM AND EFFECTIVE DATE**

This Agreement becomes effective upon execution by the signatory Parties and remains in effect until amended or superseded.

**ORIGIN OF SUBJECT:** FL-AL TPO Local Governments

**LOCAL GOVERNMENT ACTION NEEDED:** Subsequent Software Subscription may be required

**BACKGROUND:** The #1 ranked Non-Strategic Intermodal System (SIS) project in the FL-AL TPO's FY 2027 – FY2031 Project Priorities is the deployment of an Intelligent Transportation System (ITS). Over the past several years the FL-AL TPO, local governments, and the FDOT have made significant strides to develop and upgrade the overall technology infrastructure.

Local governments within the FL-AL TPO area have begun to install and utilize emergency vehicle traffic signal preemption capabilities when dealing with emergency response calls. When utilized, signal preemption is proven to reduce emergency response times by 20% or more.

Some areas within the TPO are prohibited on utilizing signal preemption due to the current outdated, legacy equipment that is not compatible with emergency vehicle signal preemption. The list below outlines the specific locations within the TPO that are needed for equipment upgrades. The equipment will not only be used for signal preemption, but safety data collection, near miss, signal timing and coordination, and upgraded traffic management capabilities.

**LOCAL GOVERNMENT ACTION NEEDED:** None

**BACKGROUND:** Annually, the TPO reviews and adopts transportation project priorities in May for submittal to the Florida Department of Transportation (FDOT) by October 1<sup>st</sup>. This document is part of the Transportation Improvement Program (TIP) development process. Its purpose is to ensure that transportation projects programmed by FDOT in the Five-Year Work Program are consistent with local needs and plans for the TPO planning area.

As stated in the TPO Public Participation Process Plan, the Project Priorities result from the Long Range Transportation Plan's Cost Feasible Plan and are reviewed with the public and the TPO Board and the advisory committees annually. Once approved by the TPO Board, the Project Priorities are given to FDOT to develop the Five-Year Work Program. From the Five-Year Work Program, the TPO develops the TIP which contains all transportation programs and projects scheduled during the next five year cycle. The TIP is revised annually and is available, in interactive format, on the TPO's website.

The Project Priorities and TIP must be developed by the TPO in consultation with all interested parties and, at a minimum, describe explicit procedures, strategies, and desired outcomes for the following, as outlined by the Code of Federal Regulation (CFR 450.316) and the MPO Handbook:

- Provide reasonable public access to technical and policy information used.
- Provide adequate public notice of public involvement activities and time for public review and comment at key decisions, such as but not limited to the approval of the TIP/Project Priorities.
- Demonstrate explicit consideration and response to public input received during plan development process.
- Make the TIP and Project Priorities drafts and final documents available on the TPO website at [www.ecrc.org](http://www.ecrc.org), a print copy of the current plan is available upon request.
- Hold public meetings at convenient times and accessible locations.
- Seek out and consider the needs of those traditionally underserved by existing transportation systems, including but not limited to, low-income and minority households.
- Coordinate with the statewide transportation planning public involvement and consultation processes under 23 C.F.R. Subpart B, as described in the FDOT MPO Program Management Handbook.
- Periodically review the effectiveness of the procedures and strategies contained in the participation plan.
- When significant written and oral comments are received on a draft TIP or Project Priorities as a result of public involvement, a summary, analysis, and report on the disposition of comments shall be made part of the final documents.
- If the final Project Priorities/TIP differ significantly from the one made available for public comment or raises new material issues, an additional opportunity for public comment must be made available.

- When the Metropolitan Planning Area (MPA) includes Indian Tribal Lands, the TPO shall appropriately involve the Indian Tribal Government(s).
- When the MPA includes federal public lands, the TPO shall appropriately involve the federal government.

General techniques proven effective include:

- Provide a 30-day public review and comment period for the draft Project Priorities documents.
- Promote development of the Project Priorities and TIP through news releases and social media, and eblast to TPO board and advisory committees, partners, stakeholders, community groups, and interested parties.

- Hold public workshop(s) and implement additional project-specific outreach, as needed, to special populations during the Project Priorities process.
- Coordinate public outreach to community groups (with emphasis on the underserved).
- Include public input collected at workshops in the draft Project Priorities and TIP.
- Include in the public notice of the TPO board meeting when the draft Project Priorities and TIP are to be presented for review and adoption.
- Provide the public with an opportunity to comment during public forum when the draft Project Priorities and TIP are presented for review and adoption to the TPO board and advisory committee meetings.
- Publish adopted Project Priorities and TIP interactive site (provided by FDOT) on website at [www.ecrc.org](http://www.ecrc.org), a print copy of the current plan is available upon request.
