CALL TO ORDER / INVOCATION / PLEDGE - Chairperson Pamn Henderson

The meeting was called to order. The prayer was led, and the pledge of allegiance was recited.

APPROVAL OF AGENDA

<u>Commissioner Dozier moved to approve the agenda. Commissioner Hamm seconded the motion, and it was unanimously approved.</u>

PUBLIC FORUM: There were no speakers.

FDOT UPDATE:

1. FDOT Update - Mr. Bryant Paulk, AICP, or Donna Green, Florida Department of Transportation (FDOT) Urban Liaisons

Bryant Paulk informed the board of a hybrid public meeting concerning the resurfacing project on S.R.79 from the West Bay Bridge to south of Crews Lake Road in Bay and Washington counties on Tuesday, Nov. 14 from 5:30 to 6:30 p.m. Bryant

Paulk stated that those who are unable to participate virtually may attend the meeting in-person at the Ebro Dog Park Restaurant, 6558 Dog Track Road, Ebro. Preregistration is required for the virtual format and encouraged for in-person attendees. The same materials will be presented for each format.

Chairperson Henderson asked for an update on the Dupont Bridge project. Bryant Paulk stated that the project is moving forward and that he could provide more details after the meeting. Chairperson Henderson also asked for an update on the flyover project in Panama City. Bryant Paulk responded that it is a part of the US 231 widening project that is fully funded for ROW acquisition in the current Five-Year Work Program. Bryant Paulk added that the construction is out in FDOT's second five years of the SIS plan.

Commissioner Griggs inquired about the signaling at the U.S. 231 at Star Avenue/Titus Road intersection that was scheduled to be completed in July and is still not done. Bryant Paulk reported that the project is running behind due to supply chain issues and FDOT being unable to obtain those infrastructure components related to signals.

Commissioner Griggs asked for an update on SR 22, the section from CR 30A to Star Avenue and Tyndall to Star Avenue. Commissioner Griggs stated that it is at the top of the priority list and asked where the funding was. Bryant Paulk stated that other projects along with that one, that are not on the SIS district wide, have languished as well. Bryant Paulk said that FDOT has not been able to produce a capacity project in many years due to increased costs across the board. Bryant Paulk said a letter could be written by the TPO requesting to break the project up even further to possibly get a smaller portion funded.

Mary Beth Washnock informed the board that the TCC made a recommendation to fund a bike pedestrian plan and stated that ECRC will have a bike/ped plan for Okaloosa Walton TPO and Bay TPO beginning in the next fiscal year starting in July of 2024. Mary Beth Washnock stated that the TCC asked if a plan could be done in this calendar year and that Bryant Paulk responded that it would be unlikely because the current work program is already in place.

PLANNING AND TRANSIT CONSENT AGENDA:

1. ALL COMMITTEES - Approval of August 2023 Meeting Minutes

Councilmember Coburn moved to approve the August 2023 Bay TPO meeting minutes. Commissioner Hamm seconded the motion, and it was unanimously approved.

PLANNING ACTION ITEMS:

1. ENCLOSURE A - ALL COMMITTEES - ROLL CALL VOTE - Consideration of Resolution BAY 23-33 Accepting the FDOT FY 2025-2029 Tentative Work Program - Mr. Bryant Paulk, AICP, FDOT

Carla Hodges presented an overview of FDOT's Tentative Work Program for FY 2025-2029. This action reflects the coordination that has occurred between the TPO and FDOT in development of the Work Program and funding of the TPO FY 2025-2029 Project Priorities.

Commissioner Street moved to authorize the TPO chairman to sign Resolution Bay 23-26 adopting the FY 2025-2029 Project Priorities. The motion was seconded by Commissioner Hamm and was passed unanimously.

ENCLOSURE B - ALL COMMITTEES - Consideration of Resolution BAY 23-34
 Adopting Statewide "Vision Zero" Targets for Safety Performance Measures - Gary Kramer, ECRC Staff

Gary Kramer presented the "Vision Zero" targets for Safety Performance Measures. Gary Kramer stated that this action complies with the February 27, 2024, deadline to remain in compliance with the Federal and State regulations for transportation planning.

Commissioner Street asked if there was data that shows the main problematic areas. Austin Mount stated that Bay County and ECRC both have Safe Streets For All planning grants. These plans will look at high crash zones and identify possible solutions. Austin Mount stated that the safe street program at the federal level has implementation funds that can be applied for in the subsequent years. Austin Mount stated that with these efforts, Bay County and ECRC will be able to provide that data to the TPO in great detail.

Commissioner Dozier moved to authorize the TPO chairman to sign Resolution Bay 23-26 adopting the FY 2025-2029 Project Priorities. The motion was seconded by Commissioner Carroll and was passed unanimously.

3. ENCLOSURE C - ALL COMMITTEES - Consideration of Resolution BAY 23-35 Adopting the Rankings of SUN (Shared Use Non-Motorized) Trail Projects - Gary Kramer, ECRC Staff

Gary Kramer presented the ranking of the SUN Trail (Shared Use Non-Motorized)

project. Gary Kramer stated that this action will allow FDOT to use the SUN Trail rankings as a guide for funding SUN Trail projects in the FDOT Work Program.

Austin Mount discussed the SUN Trail program and the priority lines that the Bay TPO added to the trail map over the last year. Austin Mount stated that those efforts helped the TPO gain eligibility for future trail funds. Austin Mount stated that the state legislature approved a one-time \$200 million dollar allocation to SUN Trail and doubled the total annual allocation to \$50 million. Austin Mount stated that FDOT asked the TPO to prioritize these projects, so moving forward there will be another page on the priority list specifically for these kinds of projects.

Commissioner Street asked if anyone can submit before the deadline, since there was not much participation. Commissioner Street said Panama City had two they could submit that they did not have time to before the deadline. Austin Mount stated that the cut off deadline would need to be November 30th to get those projects in. Austin Mount stated that projects can be added first come first serve or ECRC staff can evaluate them and then add them to the list.

After further discussion, the TPO agreed to approve the subsequent ranking of additional projects if submitted to the TPO staff and to include Tyndall AFB – SUN Trail Network (Crooked Sound Drive to Drone Recovery Road).

Commissioner Street moved to authorize the TPO chairman to sign Resolution BAY 23-35 to adopt the SUN Trail Project rankings using the ranking criteria and the subsequent ranking of additional projects if submitted to the TPO staff, adding Tyndall AFB – SUN Trail Network (Crooked Sound Drive to Drone Recovery Road). Commissioner Dozier seconded the motion, and it was unanimously approved.

Jill Nobles presented the Congestion Management Process Plan (CMPP) minor update, stating that this action provides an interim update between major updates.

Commissioner Dozier moved to authorize the TPO chairman to sign Resolution Bay 23-36 adopting the Congestion Management Process Plan minor update. Commissioner Hamm seconded the motion, and it was unanimously approved.

5. ENCLOSURE E - TPO ONLY - Appointment of Bay County TPO Board Member and Alternate to the MPOAC Governing Board for Calendar Year 2024 - Mary Beth

Washnock, ECRC Transportation Director

Mary Beth Washnock stated that the board needed to appoint one member and an alternate to the MPOAC Governing Board for 2024. Mary Beth Washnock stated that this action allows the TPO to participate with other MPOAC members to address transportation issues of common interest to all urbanized areas and MPOs in the state.

Commissioner Moore moved to appoint Commissioner William Dozier to the MPOAC Governing Board and Commissioner Josh Street as the alternate for the 2024 calendar year. Commissioner Carroll seconded the motion, and it was unanimously approved.

Jill Nobles presented the review of FDOT District Three Transportation Regional Incentive Program (TRIP) application cycle, stating that the Regional Transportation Planning Organization, ECRC, ranks and prioritizes all TRIP applications in the ECRC region. Applications are due in GAP by Friday, January 19, 2024, for ECRC prioritization.

TRANSIT ACTION ITEMS:

1. ENCLOSURE I – ALL COMMITTEES- Consideration of Resolution Bay 23-37 Authorizing Staff to Negotiate with the Lowest-Ranked Bidder to TPO-IFB #23-01 for a Building Contractor to Construct the Public Transportation System Bus Wash Facility - Lamar Hobbs, Bay County Transit

Lamar Hobbs presented and stated that an Invitation for Bids (IFB TPO 23-01 – Bus Wash Facility Construction Project) was advertised on September 7th, 2023. Responses were received on October 13th, 2023. On October 24th, 2023, the TPO Transit Subcommittee reviewed the bids and recommended staff begin negotiations with the lowest priced responsive vendor, R. E. Crawford Construction LLC.

Commissioner Dozier moved to authorize staff to negotiate a contract for construction of a bus wash facility with the top ranked firm, R. E. Crawford Construction LLC. Commissioner Griggs seconded the motion, and it was unanimously approved.

TRANSIT UPDATE

Lamar Hobbs stated that the subcommittee was supposed to discuss PO-RFP #23-02 for the Operator for Deviated Fixed Route, Demand Response, and Micro-Transit Public Transportation Services at their previous meeting. Lamar Hobbs explained that Chairperson Pamn Henderson, indicated that she was unable to download all the pages for each of the submittals using the solicitation software and as a result was not comfortable participating in a decision to recommend a proposal to the TPO Board. Lamar Hobbs stated he contacted Bay County's Chief Procurement Officer, Karen Grindle, for guidance on how to proceed. After discussing the situation with the Bay County Procurement Office, Lamar Hobbs stated that it was determined that the agenda item would be held for a date in the future to correct any issues with the solicitation software and ensure every member of the TPO Subcommittee had the opportunity to fully review each solicitation prior to making a recommendation to the TPO Board.

The TPO Subcommittee requested a special call meeting be scheduled for them to reconvene and consider the agenda items once everyone had the opportunity to properly review the proposals. Lamar Hobbs stated that a special call meeting of the TPO Subcommittee was

scheduled for November 15th, 2023, at 1:30 PM CST.

Lamar Hobbs explained that the operator contract expires December 31st and the TPO will not meet again before that. Lamar Hobbs asked the TPO to consider allowing Bay County's approval to move forward with the contract. The contract would then be available for the TPO to review at the next TPO meeting.

Commissioner Grainger moved to approve deferring the review and ranking of submissions from bidders in response to TPO-RFP #23-02 for the Operator for Deviated Fixed Route, Demand Response, and Micro-Transit Public Transportation Services to a meeting on November 15th at 1:30 p.m. and subsequent approval by the Bay County Board of County Commissioners in November. Commissioner Street seconded the motion, and it was unanimously approved.

Lamar Hobbs stated that FSU's ridership is through the roof so they will need to go back and renegotiate some costs.

GOVERNANCE TRANSIT COMMITTEE UPDATE - Chris Cochran, AICP, Madrid CPWG

Lamar Hobbs stated that the draft bill for the GTC has been sent to draft services and everything is moving along.

Chris Cochran gave an update on the bill process and the local delegation's support for the draft local bill language. Chris Cochran stated that first and foremost, one of the items discussed was to define a name for the transit authority that needed to be included in the legislative language. The name that has been decided on is *Gulf Coast Transit Authority*, with the understanding that it would still be doing business as *BayWay*. Chris Cochran concluded by stating that the bill is still on schedule to be submitted in January.

ORIGIN OF SUBJECT: Unified Planning Work Program (UPWP) Task 3: Data Development and Management

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The purpose of TSM planning is to identify operational improvements to enhance the capacity of the existing system. Through better management and operation of existing transportation facilities, techniques are designed to improve traffic flow, air quality, and movement of people and goods, as well as enhance system accessibility and safety. Transportation systems management strategies are lower cost but effective in nature. Techniques include, but are not limited to, intersection and signal improvements, freeway bottleneck removal programs, data collection to monitor system performance, and special events management strategies.

As per the UPWP, ECRC staff is reevaluating the adopted evaluation criteria used to rank candidate projects. Comments will be collected through January 19, 2024.

RESOLUTION BAY 24-01

A RESOLUTION OF THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION ADOPTING THE EVALUATION CRITERIA FOR EMERALD COAST REGIONAL COUNCIL STAFF RANKING OF TRANSPORTATION SYSTEM MANAGEMENT (TSM) PROJECTS

WHEREAS, the Bay County Transportation Planning Organization (TPO) is the organization designated by the governor of Florida as being responsible, together with the state of Florida, for carrying out the continuing, cooperative and comprehensive transportation planning process for the Bay County TPO Planning Area; and

WHEREAS, the Transportation System Management (TSM) planning is outlined in the TPO's Unified Planning Work Program to identify operational improvements to enhance the capacity of the existing system; and

WHEREAS, Emerald Coast Regional Council staff ranks candidate TSM projects;

NOW, THEREFORE, BE IT RESOLVED BY THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION THAT:

ORIGIN OF SUBJECT: 23 Code of Federal Regulations Section 134(j), Chapter 339.175 (8)(b) Florida Statutes, Bay County TPO Unified Planning Work Program (UPWP) Short Range Planning Task

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: Annually, the TPO reviews and adopts transportation project priorities in August for submittal to FDOT by October 1st. This document is part of the Transportation Improvement Program (TIP) development process. Its purpose is to ensure that transportation projects programmed by FDOT in the Five-Year Work Program are consistent with local needs and plans for the TPO planning area.

As stated in the TPO Public Participation Process Plan, the Project Priorities result from the Long Range Transportation Plan's Cost Feasible Plan and are reviewed with the public, the TPO Board, and the advisory committees annually. Once approved by the TPO Board, the Project Priorities are given to FDOT to develop the Five-Year Work Program. From the Five-Year Work Program, the TPO develops the TIP which contains all transportation programs and projects scheduled during the next five year cycle. The TIP is revised annually and is available, in interactive format, on the TPO's website.

The Project Priorities and TIP must be developed by the TPO in consultation with all interested parties and, at a minimum, describe explicit procedures, strategies, and desired outcomes for the following, as outlined by the Code of Federal Regulation (CFR 450.316) and the MPO Handbook:

- Provide reasonable public access to technical and policy information used.
- Provide adequate public notice of public involvement activities and time for public review and comment at key decisions, such as but not limited to the approval of the TIP/Project Priorities.
- Demonstrate explicit consideration and response to public input received during plan development process.
- Make the TIP and Project Priorities drafts and final documents available on the TPO website at www.ecrc.org, a print copy of the current plan is available upon request.
- Hold public meetings at convenient times and accessible locations.
- Seek out and consider the needs of those traditionally underserved by existing transportation systems, including but not limited to, low-income and minority households.
- Coordinate with the statewide transportation planning public involvement and consultation processes under 23 C.F.R. Subpart B, as described in the FDOT MPO Program Management Handbook.
- Periodically review the effectiveness of the procedures and strategies contained in the participation plan.
- When significant written and oral comments are received on a draft TIP or Project Priorities
 as a result of public involvement, a summary, analysis, and report on the disposition of
 comments shall be made part of the final documents.

- If the final Project Priorities/TIP differ significantly from the one made available for public comment or raises new material issues, an additional opportunity for public comment must be made available.
- When the Metropolitan Planning Area (MPA) includes Indian Tribal Lands, the TPO shall appropriately involve the Indian Tribal Government(s).
- When the MPA includes federal public lands, the TPO shall appropriately involve the federal government.

General techniques proven effective include:

- Provide a 30-day public review and comment period for the draft Project Priorities documents.
- Promote development of the Project Priorities and TIP through news releases and social media, and eblast to TPO board and advisory committees, partners, stakeholders, community groups, and interested parties. (subscribe online at www.ecrc.org).
- Hold public workshop(s) and implement additional project-specific outreach, as needed, to special populations during the Project Priorities process.
- Coordinate public outreach to community groups (with emphasis on the underserved).
- Include public input collected at workshops in the draft Project Priorities and TIP.
- Include in the public notice of the TPO board meeting when the draft Project Priorities and TIP are to be presented for review and adoption.
- Provide the public with an opportunity to comment during public forum when the draft Project Priorities and TIP are presented for review and adoption to the TPO board and advisory committee meetings.
- Publish adopted Project Priorities and TIP interactive site (provided by FDOT) on website at www.ecrc.org, a print copy of the current plan is available upon request.

TPO responsibilities require that all modes of transportation be addressed in the Project Priorities. The following categories of projects are included in the Priorities:

- 1. Long Range Transportation Plan Capacity Projects
- 2. Transportation Systems Management Projects
- 3. Transportation Alternative Projects

PLANNING ACTION ITEMS:

FDOT Tentative Work Program

The TPO approved Resolution BAY 23-33 accepting the FDOT FY 2025-2029 Tentative Work Program. This action reflects the coordination that has occurred between the TPO and FDOT in the development of the Work Program and funding of the TPO FY 2025-2029 Project Priorities.

Safety Performance Measures

The TPO approved Resolution BAY 23-34 adopting statewide "Vision Zero" targets for safety performance measures. This action complies with the February 27, 2024, deadline to remain in compliance with the Federal and State regulations for transportation planning.

1. Service

- A. The Bay County Public Transit System shall provide fixed route public transportation service operating under the name Bayway, each Sunday of the week for the applicable program period, as described below.
- B. The Bay County Public Transit System shall operate the service on a modified schedule to mirror the exsisting Saturday schedule. The hours of operation for the Sunday service will begin at 6:00am and end at 8:00pm.
- C. Panama City Beach Convention and Visitors Bureau (CVB) will promote and market the program to encourage tourist and residents of Panama City Beach to utilize public transportation. The Bay County Public Transit System will provide marketing materials (i.e. banners, posters, and brochures) regarding the Program for the CVB to use. The CVB will provide an acceptable physical location to display the program marketing materials. The Bay County Public Transit System marketing materials may also be digital communications which the CVB shall distribute to residents and tourist through emails, social media and on the CVB's website. Both the Bay County Public Transit System and CVB shall obtain each other's consent and approval for any marketing materials developed prior to distribution of such materials.

2. Term

A. For Year Two:

The additional Sunday service shall commence on <u>March 3, 2024</u> and terminate on <u>November 24, 2024</u>.

B. If the additional Sunday service is terminated, both the Bay County Public Transit System and the CVB shall be responsible for posting notices notifying the riders of the service termination at least 30 days prior to the termination date.

3. Eligible Participants

A. An "Eligible Participant" is defined as a resident or visitor residing within or visiting Bay County, Florida who wishes to utilize public transportation to get to and from Panama City Beach, Florida.

4. Pricing

A. The valid dates and maximum price the Bay County Public Transit System can charge the CVB for each year are as follows:

Number of hours per day (14 hours x 4 buses)	56
Operator rate per hour*	\$63.94

- B. For each **Program Period**, the following invoice amount and reconciliation procedure shall apply:
 - 1. The invoice amount will be established as follows: The total monthly invoice amount will be calculated by <u>multiplying the Operator's rate per day by the total number of Sundays worked during the month</u>. (Example: 4 Sundays x \$3,580.64 = \$14,322.56)
 - 2. The Bay County Public Transit System shall submit to the CVB a monthly invoice approximately 15 days after the end of the month.

6. **Payment**

A. The CVB shall pay the Bay County TPO the full amount invoiced within 30 days of receipt of invoice for the services rendered. Please remit all payments to:

7. Compliance with Applicable Law

A. Bay County Public Transit System agrees to comply with all applicable provisions of all federal, state and local laws and regulations.

ORIGIN OF SUBJECT: Bay County Board of County Commissioners' Staff on Behalf of TPO

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: On December 23, 2023, the six-month extension to the agreement for management and operations services for the fixed route system expired. An RFP was issued on September 1, 2023 for a new agreement for management and operations services. A total of four proposal were received. A review of the proposals indicated that only one of the bidders possessed the required Med-Waiver as outlined in the RFP. It was further determined that two of the proposers did not use the estimated number of services hours articulated in the RFP to calculate their annual cost.

On November 16, 2023, Bay County Administration notified its staff that two members of the TPO Subcommittee had contacted them concerned about the discrepancies mentioned above. After further review by County Purchasing, Legal, and Administration, it was recommended that all the proposals received in response to the RFP be rejected. It was further recommended that the RFP be re-advertised to ensure all potential vendors have a fair and equitable opportunity to bid. As a result of the agreement not being awarded on or by December 23, 2023, an amendment to the current agreement was necessary to ensure the continuation of fixed route services in Bay County.

An amendment was entered into between the Bay County TPO and First Transit for management and operations services for the fixed route system effective December 24, 2023, and continuing for a period of not more than twelve months. The negotiated price for the extension is \$52.37 per revenue hour and a monthly fixed rate of \$56,664.22 per month.

WHEREAS, it was necessary for the Bay County TPO to issue an amendment to extend the current agreement with First Transit for management and operations of the fixed routes system in order to ensure its continued operation after December 23, 2023;

NOW, THEREFORE BE IT RESOLVED BY THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION (TPO) THAT:

The TPO approves an amendment to the agreement with First Transit for management and operations services, to begin December 24, 2023 and not to extend a twelve month term.

AMENDMENT TO AGREEMENT FOR MANAGEMENT AND OPERATION SERVICES OF THE FIXED ROUTE SYSTEM

THIS AMENDMENT TO THE AGREEMENT FOR MANAGEMENT AND OPERATIONS SERVICES OF THE FIXED ROUTE SYSTEM ("Amendment") is made and entered into this 23rd day of December, 2023 by and between BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION (hereinafter referred to as the "TPO") with administrative offices located at 1010 Cone Avenue, Panama City, Florida 32401 (Bayway Administration Facility), and FIRST TRANSIT, INC., A FOR-PROFIT CORPORATION authorized to do business in the State of Florida (hereinafter referred to as "First Transit"), whose federal employer identification number is 231716119 and whose principal address is 300 E. Butterfield Road, Lombard, Illinois 60148.

WITNESETH:

WHEREAS, August 13, 2014, TPO and First Transit enter into an Agreement for Management and Operation Services for the Bayway Deviated Fixed Route System having an initial term beginning July 1, 2014 and ending June 30, 2019 ("Agreement");

WHEREAS, June 11, 2019 and October 12, 2021, respectively, TPO and First Transit by mutual agreement extended that Agreement for two additional two-year terms such that the term of the Agreement was extended through June 30, 2023;

WHEREAS, On or about April 5, 2023, the parties entered into an TPO and First Transit by mutual agreement entered into an amendment to the Agreement extending the term thereof for an additional six (6) months beginning on July 1, 2023 and ending December 23, 2023;

WHEREAS, this Addendum is entered into by mutual agreement between TPO and First Transit in an effort to provide continuing service to the public through the fixed route system;

NOW THEREFORE, in consideration of the mutual terms, conditions, and covenants contained herein, the TPO and First Transit hereby agree as follows:

- 1. The TPO and First Transit mutually agree that the term of the Agreement is hereby extended for a period of one (1) year commencing December 23, 2023 and ending on December 23, 2024 ("Extended Term"). During the Extended Term the TPO shall pay First Transit a rate of \$52.37 per revenue hour and a monthly fixed rate of \$56,664.22 per month.
- 2. Except as expressly provided and amended herein, all other covenants, terms, and conditions of the Agreement shall remain the same.

Memorandum of Agreement

Bay County Transportation Planning Organization And

Panama City Beach Convention and Visitors Bureau Beaches Flag Safety System Advertisement

1. Service

- A. The Bay County Public Transit System shall provide advertising space on the exterior sides of two (2) demand response vehicles used daily for public transportation service and operating under the name Bayway.
- B. The Bay County Public Transit System in coordination with the Panama City Beach Convention and Visitor Bureau shall design, produce, install, and remove upon completion, the vinyl wraps displaying the Beaches Flag Safety System to be affixed on two (2) demand response vehicles.
- C. The Bay County Public Transit System agrees to operate said vehicles with said advertisements Monday thru Saturday between the hours of 6:00 AM and 6:00 PM. The Bay County Public Transit System reserved the right to remove said vehicles from service if they deem it necessary.
- D. Panama City Beach Convention and Visitors Bureau (CVB) will provide marketing materials (i.e. banners, posters, and brochures) regarding the Program for the Bay County Public Transit System to use. Both the Bay County Public Transit System and CVB shall obtain each other's consent and approval for any advertising materials developed prior to distribution of such materials.

2. Term

A. This agreement shall commence on March 3, 2024 and terminate on October 27, 2024.

3. Pricing

- A. The cost of the design, production, installation, and removal of the vinyl wraps for two demand response vehicles will be provided <u>in-kind</u> for the funding needed to provide for the operation of fixed route public transit service on Sundays during the months of March to October 2024.
- B. The cost of the monthly advertising rate to advertise on two demand response vehicles will be provided in-kind for the funding needed to provide for the operation of fixed route public transit service on Sundays during the months of March to October 2024.

4. Compliance with Applicable Law

A. Bay County Public Transit System agrees to comply with all applicable provisions of all federal, state and local laws and regulations.

8. Public Records

A. IF THE PANAMA CITY BEACH CONVENTION AND VISITORS BUREAU HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO THE PANAMA CITY BEACH CONVENTION AND VISITORS BUREAU'S DUTY TO PROVIDE PUBLIC RECORDS
