#### **CALL TO ORDER / INVOCATION / PLEDGE**

#### **APPROVAL OF AGENDA**

<u>Commissioner Pease moved to approve the agenda as presented. Commissioner Lucas seconded the motion, and it was unanimously approved.</u>

#### **PUBLIC FORUM:**

Lamar Hobbs, BayWay, stated that BayWay was awarded the transit agency of the year for the state of Florida in 2024 and recognized three BayWay employees for helping people in crisis. The employees were given the "Better Bayway" award. Lamar Hobbs stated that in May, Kathy Mordecai, noticed an elderly woman who seemed to be confused and had the potential to walk into a busy road. Kathy Mordecai pulled over and called dispatch as well as the Bay County Sheriff's Office. They identified the woman, who was thought to have

dementia, and she waited on the bus until she was reunited with her family members. The driver received an award for exceptional care and assistance.

Lamar Hobbs stated that this year, BayWay employees at the transit agency were trained to assist minors going through crisis. In April, driver Sara Horton discovered a young boy who was wandering alone and notified dispatch. Bayway's road supervisor, Antrese McCormick, came to the scene and took the boy to the police station. Operators suggested there might be another child wandering in the area, so the driver and road supervisor searched the area and found a second unattended child, a 4-year-old girl. Bayway employees waited with her until the Springfield Police Department arrived. The driver and the supervisor both received an award for swift action and unwavering commitment to the safety and well-being of children.

Chair Henderson welcomed the two new Bay County commissioners, Commissioner Daniel Raffield and Commissioner Doug Crosby.

#### FDOT UPDATE: FDOT Update - Bryant Paulk, AICP Florida Department of Transportation (FDOT) Urban Liaisons

Bryant Paulk gave a report on the recent virtual project update on the multi-use path in Mexico Beach. The project is currently under PD&E.

Bryant Paulk gave an update on two additional projects, stating that the re-alignment of Star Avenue and Titus Road at U.S. 231 project is still on schedule for a February 2025 letting date. Bryant Paulk also reported that the final segment of the Panama City Beach Parkway widening project is scheduled for a February 2026 letting date.

Bryant Paulk stated that the TPO board requested FDOT to investigate access management opportunities along the Martin Luther King Blvd. corridor in Panama City. The FDOT traffic operations office looked at any interim improvements or immediate safety improvements that were required and did not find any due to the corridor being fairly restrictive.

**BACKGROUND:** The Federal Transit Administration (FTA) has established several policies that are meant to ensure that buses purchased or leased with Federal funds are maintained and remain in transit use for a minimum useful life. Useful life of rolling stock begins on the date the vehicle is placed in revenue service and continues until it is removed from service. Minimum useful life for a medium duty bus is achieved when the vehicle has reached at least seven years of service and an accumulation of at least 250,000 miles, whichever comes first. Based on the aforementioned policies the vehicles have reached their minimum useful life and are available to be surplused.

**WHEREAS**, the FTA and FDOT require recipients of federal and state funds to maintain transit infrastructure in a "state of good repair" so that the public transit system is provided to the communities in an efficient, reliable, and safe manner; and

**WHEREAS**, the FTA and FDOT have established several policies that are meant to ensure that buses purchased or leased with federal and/or state funds are maintained and remain in transit use for a minimum useful life; and

**WHEREAS**, the FTA and FDOT consider the minimum useful life for medium duty transit buses to be at least seven years of service and/or an accumulation of at least 250,000 miles; and

**WHEREAS**, transit vehicles 1401, 1402, and 1403, all of which are 2014 Eldorado EZ Rider II medium duty transit buses have been in service for at least seven years and have exceeded the minimum required mileage of 250,000 miles;

#### NOW, THEREFORE BE IT RESOLVED BY THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION (TPO) THAT:

The TPO approves a resolution authorizing the surplus of transit vehicles 1401 (2014 Eldorado EZ Rider II VIN: 1N9MNAC66EC084386) 1402 (2014 Eldorado EZ Rider II VIN: 1N9MNAC66EC084387), and 1403 (2014 Eldorado EZ Rider II VIN: 1N9MNAC66EC084388)

**BACKGROUND**: The Bipartisan Infrastructure Law (BIL) established the new SS4A discretionary program, with \$5 billion in appropriated funds over five years, 2022-2026. The SS4A program funds regional, local, and tribal initiatives through grants to prevent roadway deaths and serious injuries.

As a recipient of an SS4A grant, Bay County will produce a Safety Action Plan. The Safety Action Plan will assist Bay County and local jurisdictions within Bay County in achieving the target of zero fatalities and serious injuries.

The Safety Action Plan has included robust engagement with the public and relevant stakeholders, including the private sector and community groups, allowing for community representation and feedback. Information received from engagement and collaboration was analyzed and incorporated into the plan. Overlapping jurisdictions were included in the process. Plans and processes were coordinated and aligned with other governmental plans and planning processes to the extent practical.

Bay County and Michael Baker International will provide an overview on the project at the February TPO and advisory committee meetings. An overview of the Bay County Safety Action Plan status and preliminary findings can be accessed on the project website:

## A RESOLUTION OF THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION SUPPORTING DEVELOPMENT OF THE BAY COUNTY SAFETY ACTION PLAN

**WHEREAS**, the Bay County Transportation Planning Organization (TPO) is the organization designated by the governor of the State of Florida as being responsible, together with the State of Florida, for carrying out the continuing, cooperative and comprehensive transportation planning process for the Bay County TPO Planning Area; and

**WHEREAS**, it is critical for the TPO to support Bay County's efforts to develop a comprehensive Safety Action Plan to ensure the safety of pedestrians, cyclists, and road users of all ages and abilities within Bay County; and

**WHEREAS**, fatal and severe crashes are preventable, and death and serious injury are currently an unacceptable cost on our roadway system; and

**WHEREAS**, pedestrians, bicyclists, and motorcyclists represent the most vulnerable road users and represent approximately 52% of all fatal traffic crashes and 40% of all severe injury crashes in the Bay County TPO area between July 2019 and June 2024; and

**WHEREAS**, the TPO adopts annual safety performance measures as part of the federally required safety performance measures; and

**WHEREAS**, the U.S. Department of Transportation has adopted the Safe System approach and Florida Department of Transportation (FDOT) has adopted a Target Zero Initiative; and

**WHEREAS**, the Emerald Coast Regional Council (ECRC) and the Florida-Alabama, Okaloosa-Walton, and Bay County TPOs have adopted a Vision Zero goal; and

**WHEREAS**, the Bay County Safety Action Plan with Top 100 locations for fatal and serious injury crashes was developed with a data driven approach along with input from stakeholders, members of the public, and a multi-disciplinary Task Force comprised of representatives from local organizations and agencies with expertise in transportation, roadway engineering, law enforcement, emergency response, equity, transit, biking, and walking;

#### NOW, THEREFORE, BE IT RESOLVED BY THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION THAT:

**WHEREAS**, 23 Code of Federal Regulations (CFR), Part 450, Subpart C, Section 316 (e) states the metropolitan planning process shall, "develop a documented process(es) that outlines roles, responsibilities, and key decision points for consulting with other governments and agencies;" and

**WHEREAS**, in general, federal legislation built upon previous transportation legislation (ISTEA, TEA-21, and SAFETEA-LU) to provide states and metropolitan planning organizations with specific direction in conducting and promoting broad-based public participation activities; and

**WHEREAS**, federal legislation requires metropolitan planning organizations to provide citizens, affected public agencies, representatives of public transportation employees, freight shippers, providers of freight transportation services, private providers of transportation, representatives of users of public transportation, representatives of users of pedestrian walkways and bicycle transportation facilities, representatives of the disabled and other interested parties with a reasonable opportunity to comment on the transportation plan;

## NOW, THEREFORE, BE IT RESOLVED BY THE BAY COUNTY TRANSPORTATION PLANNING ORGANIZATION THAT:

- 1) The TPO has reviewed its public involvement procedures, hereafter referred to as the Public Participation Plan, to ensure that full and open access to the LRTP planning and TPO decision-making process is provided for all citizens and finds the document to comply with the Code of Federal Regulation (CFR 450.316) and the Florida Metropolitan Planning Organization (MPO) Handbook.
- 2) The TPO adopts the Long Range Transportation 2050 Public Participation Plan.

#### Why is Public Involvement Important?

One of the elements of the Long Range Transportation Plan (LRTP) is public involvement. Engaging more citizens in the planning process leads to a stronger plan that better addresses the community's needs. Providing opportunities for public participation helps minimize challenges in later phases of the plan by identifying and addressing potential issues during the planning stage. The Bay County Transportation Planning Organization (TPO) Public Participation Plan (PPP) provides a framework for the development of the Public Involvement Plan (PIP) specific to the Long Range Transportation Plan.

#### **Long Range Transportation Plan**

The Long Range Transportation Plan (LRTP) is a federally required document, updated every five years, that addresses future transportation needs for at least a twenty-year horizon.

Public involvement strategies for each LRTP update should incorporate a variety of outreach activities designed to solicit feedback from stakeholders of all ages, communities, and interests throughout all stages of the planning process. Additionally, all outreach activities must adhere to the following procedures, strategies, and desired outcomes outlined in the Code of Federal Regulation (CFR 450.316) and the Metropolitan Planning Organization (MPO) Handbook. These strategies include:

- Provide reasonable public access to technical and policy information used in the development of the LRTP through the Transportation Planning Organization (TPO)/Emerald Coast Regional Council website;
- Provide adequate public notice of public involvement activities and sufficient time for public review and comment on key decisions, such as but not limited to the approval of the LRTP;
- Demonstrate explicit consideration and response to public input received during the plan development process;
- Use visualization techniques to describe the LRTP;
- Hold public meetings at convenient times and accessible locations;
- Seek out and consider the needs of those traditionally underserved by existing transportation systems, including but not limited to low-income and minority households;
- Coordinate with the statewide transportation planning public involvement and consultation processes, as outlined under 23 C.F.R. Subpart B;
- Periodically review the effectiveness of the procedures and strategies contained in the participation plan;

- Incorporate a summary, analysis, and report on the disposition of written and oral comments received on the draft LRTP, including the financial plan, as part of the final LRTP; and
- Provide additional opportunities for public comment if the final LRTP differs significantly from the draft version made available for public comment or if new material issues arise.
- Allow a 30-day formal comment period for major LRTP amendments. Public participation procedures may vary depending on the nature of the amendment.

#### **Stakeholders**

Stakeholders will include identified neighborhood associations, affordable housing organizations, community organizations, federally designated and non-federally recognized Native American Tribes, Federal Land Management Agency (FLMA), and major employers in the TPO area. Contact lists will be developed containing stakeholder emails and phone numbers. These contact lists will be used to promote participation in the LRTP process, facilitate presentations, and assist in forming a steering committee. The steering committee will review key components of the LRTP, including the kick-off meeting, Goals and Objectives, Needs Plan, and Cost Feasible Plan.

#### Citizens Advisory Committee

The Citizens' Advisory Committee (CAC) is composed of members of the public who have expressed an interest in transportation planning. The TPO board approves CAC membership. Citizens interested in joining or learning more about the CAC can email <a href="marketing@ecrc.org">marketing@ecrc.org</a> for additional information.

#### **Technical Coordinating Committee**

The Technical Coordinating Committee (TCC) comprises local government and transportation professionals. This committee plays a vital role in the planning process by providing technical advice to the TPO board on transportation-related issues.

#### Transportation Planning Organization Board

The Bay County Transportation Planning Organization serves as Bay County, Florida's local, intergovernmental transportation policy board. The board is composed of local government officials who make transportation-related decisions at a regional level.

#### Other TPO Committees

Presentations will be made to other TPO committees and groups as needed to ensure broad engagement and feedback throughout the planning process.

#### **Long Range Transportation Plan Study Area**

The Study Area includes Bay County, Florida. To ensure that staff is effectively reaching the right communities and coordinates with agencies and stakeholders in the region, the Bay County TPO Community Profile—created as part of the Bay County TPO Title VI Plan—will be updated during the information phase of the Long Range Transportation Plan process.




Figure 1: Map illustrating boundaries of the Bay County TPO

#### **Public Participation Goals**

The Bay 2050 Long Range Transportation Plan incorporates four primary public participation and outreach goals, as outlined in the Bay County Public Participation Plan (PPP). These goals are as follows:

#### Goal 1: Early and Consistent Involvement

Engage the public and stakeholder agencies early in the project and throughout each key phase of the planning process:

- Information Phase Inform the public and stakeholders about the plan's purpose, timeline, major milestones, and how they can stay involved and informed.
- Decision-making Phase Identify specific opportunities for the public and stakeholders input at key decision-making points that affect the development of the plan.
- Review Phase Allow the public to review and provide input on a draft version of the completed plan.

#### **Goal 2: Opportunity**

Ensure citizens and stakeholder agencies have meaningful opportunities to participate in all phases of the public involvement process. Special emphasis will be placed on engaging traditionally under-represented or under-served communities.

#### Goal 3: Information and Communication

Provide citizens and stakeholder agencies with clear, timely, and accurate information about the plan as it progresses as it progresses, ensuring transparency and accessibility.

#### Goal 4: Range of Techniques

Implement a broad spectrum of outreach techniques to engage the diverse populations within the project area.

To achieve these goals, a wide range of public involvement and outreach methods will be proposed and utilized during the 2050 Long Range Transportation Plan update.



## **Traditionally, Under-Represented and Under-Served Populations**

Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, and national origin in programs and activities receiving federal funds. In addition to considering minority and low-income persons as required by Title VI of the Civil Rights Act of 1964, Executive Order 12898 - Federal Actions to Address Environmental Justice (EJ) in Minority Populations and Low-Income Populations, the TPO identifies and addresses, as appropriate, disproportionately high and adverse human health or environmental impacts of its programs, policies, and activities on minority populations and low-income populations within the Bay County TPO Study Area.

The Project Team for the 2050 Long Range Transportation Plan will integrate the Title VI and EJ principles into the planning process as developed and implemented through an ongoing initiative. This effort aims to advance racial equity, support underserved and disadvantaged communities, and identify EJ areas for consideration in the 2050 Long Range Transportation Plan.

ZIP codes within Bay County with higher concentrations of minority, transit-dependent, low-income, older adult, and Limited English Proficiency will be identified as EJ areas.

Throughout the project, participants in public outreach activities will be asked to provide their residential ZIP codes. The Project Team will periodically analyze participation from these ZIP codes to assess engagement levels in EJ areas compared to the broader study area. This analysis will determine the effectiveness of outreach activities in reaching individuals in EJ areas.

If participation from EJ areas is disproportionately low, the Project Team will implement targeted measures to improve engagement. For example:

- If a transit-dependent EJ area shows significantly low participation, smaller community meetings or outreach events may be held within the immediate area to minimize travel barriers.
- The Project Team will collaborate with counties and municipalities to identify accessible meeting locations to enhance participation, particularly from priority groups.

These measures aim to ensure inclusive and equitable participation throughout the planning process.



#### **Public Participation and Outreach Strategies**

The following methods have proven effective in previous outreach efforts by the TPO and will guide future activities:

- Review previous assessments and LRTP activities to identify successful and unsuccessful public outreach approaches.
- Analyzing Community Profiles to understand the demographics of the TPO Study Area, including traditionally underserved communities, to guide outreach strategies.
- Develop a list of specific public involvement and outreach tasks to include in the draft scope of services.

Specific requirements and strategies for public involvement are outlined in the complete Bay County TPO Public Participation Plan, available at <a href="https://www.ecrc.org/BAYTPO">www.ecrc.org/BAYTPO</a>.

Strategies used by the TPO may include:

#### Outreach

- Identifying stakeholders, organizations, traditionally underserved communities, tribal organizations, and media outlets.
- Utilizing Virtual Public Involvement (VPI) tools.
- Distributed news releases and conducted radio/TV interviews.
- Posting public notices.
- Creating and distributing surveys with at least a 30-day timeframe for public comment.
- Hosting public open houses, workshops, forums, and focus groups.
- Delivering presentations to civic and community groups.
- Providing comment cards.
- Using GIS maps and other technology tools.
- Developing and staffing a steering committee.

#### Awareness/Education

- Sending email notifications to stakeholders, organizations, underserved communities, tribal organizations, and media outlets.
- Creating social media posts, hosting events, and/or organizing Virtual Open Houses.
- Maintaining a dedicated section on the TPO website for updates and information.

#### **Documentation**

- Compiling survey results and comments.
- Mapping outreach locations using GIS tools.
- Documenting outreach events with photos.
- Tracking email open and click rates.
- Measuring social media engagement.

Posting oral and written comments alongside draft documents on the TPO website.

#### **Public Meetings**

The TPO follows these procedures for public meetings:

- 1. Publishing a legal notice in the newspaper with the largest circulation within the TPO Study Area at least seven days before public meetings. \*
- 2. Creating a social media event or post.
- 3. Issuing a news release or reminder release. \*
- 4. Listing the event on the website calendar.
- 5. Send email notifications to TPO/TCC/CAC members, interested parties, and city and county partners.

\* In compliance with the Americans with Disabilities Act (ADA), reasonable accommodations to access information, meetings, and services for individuals with Limited English Proficiency are available upon request. Individuals requiring special accommodations under the ADA or translation services should contact us toll-free at 1-800-226-8914, ext. 203, or use TTY-Florida at 1-800-995-8771 at least 48 hours in advance.

#### **Public Workshops**

Public workshops follow the same procedures as public meetings and may also include:

- 1. Emailing flyers to committees, interested parties, public transit providers, and community facilities.
- 2. Posting event details on community event calendars, such as those for libraries and community centers.

3. Developing tailored presentations as needed.

#### Presentations to Groups and Organizations

For presentations to groups and organizations, the following steps will be taken:

- 1. Creating tailored presentation materials as needed.
- 2. Sending a follow-up note of thanks and providing a summary of questions and comments to the meeting coordinator.

Outreach activities will be regularly assessed to evaluate their effectiveness. Adjustments will be made as needed to improve public engagement and ensure inclusivity.

#### **Public Participation Schedule**

To ensure the implementation of effective strategies, the public involvement team will provide a public participation schedule as part of the 2050 Long Range Transportation Plan Scope of Work. This schedule will align with the overall LRTP update process and outline specific public outreach strategies for key phases, including kick-off meeting, Goals and Objectives, Needs Plan, and Cost Feasible Plan.

#### **Assessment of Public Participation Strategies**

The Bay County TPO is committed to evaluating the effectiveness of its public participation strategies to ensure that time and resources are being used efficiently and that public participation activities are achieving their intended goals. As a standard practice, the TPO evaluates public outreach activities quarterly for all projects and initiatives.

If an assessment indicates that the public participation goals are not being met, strategies may be modified or replaced to improve effectiveness.

The effectiveness of the TPO's public participation activities is measured using the following metrics:

- Number and quality of outreach opportunities.
- Number and reach of social media posts.
- Number of eblasts sent.
- Number of news release subscribers (media, groups, and organizations) and news releases distributed.
- Number of attendees at public workshops and the number of comments received.
- Number of completed surveys.

Regular assessments help the TPO identify areas for improvement and ensure meaningful public engagement in the LRTP process.

#### **LOCAL GOVERNMENT ACTION NEEDED:** None

**BACKGROUND**: The Transportation Alternatives (TA) Set-Aside provides funding for programs and projects consistent with Fixing America's Surface Transportation (FAST) Act under 23 U.S.C. 133(h). These set-aside funds include all projects and activities defined as TA: on - and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation, community improvement activities, environmental mitigation, and projects for planning, designing, or constructing boulevards and other roadways largely in the right-of-way of formerly divided highways.

<u>Education Workshop</u>: The Bay County TPO hosted a TA Education Workshop on Monday, December 16, 2024. The purpose of this workshop was to review the previously approved TPO criteria and submittal deadlines and to receive FDOT guidance on the application documents.

<u>FDOT Guidance</u>: FDOT District 3 issued guidance on the 2025 TA Set-Aside cycle for the Fiscal Year 2027 – 2031 Tentative Work Program on November 1, 2024. The guidance specified that each TPO may submit up to three (3) prioritized projects from each TPO area.

The following three projects were submitted to be ranked and submitted to FDOT:

- Bay County-Manolia Beach Road Multi-Use Path (West of Pelican Bay Drive to East of Mystic Lane)
- City of Callaway-South Gay Avenue Sidewalk Project (Boat Race Road to Cherry Street)
- City of Lynn Haven-Carolina Avenue & 14<sup>th</sup> Street Sidewalk (SR 390 to West 14<sup>th</sup> Street & SR 390 to Maryland Avenue)

<u>ECRC Review and Workshop</u>: Applications eligible for submittal to ECRC were due January 17, 2025. An application review workshop was held on Monday, January 27, 2025.



#### **LOCAL GOVERNMENT ACTION NEEDED: None**

**BACKGROUND:** Annually, the TPO reviews and adopts transportation project priorities in May for submittal to FDOT by October 1<sup>st</sup>. This document is part of the Transportation Improvement Program (TIP) development process. Its purpose is to ensure that transportation projects programmed by FDOT in the Five-Year Work Program are consistent with local needs and plans for the TPO planning area.

As stated in the TPO Public Participation Process Plan, the Project Priorities result from the Long Range Transportation Plan's Cost Feasible Plan and are reviewed with the public and the TPO Board and the advisory committees annually. Once approved by the TPO Board, the Project Priorities are given to FDOT to develop the Five-Year Work Program. From the Five-Year Work Program, the TPO develops the TIP which contains all transportation programs and projects scheduled during the next five year cycle. The TIP is revised annually and is available, in interactive format, on the TPO's website.

The Project Priorities and TIP must be developed by the TPO in consultation with all interested parties and, at a minimum, describe explicit procedures, strategies, and desired outcomes for the following, as outlined by the Code of Federal Regulation (CFR 450.316) and the MPO Handbook:

- Provide reasonable public access to technical and policy information used.
- Provide adequate public notice of public involvement activities and time for public review and comment at key decisions, such as but not limited to the approval of the TIP/Project Priorities.
- Demonstrate explicit consideration and response to public input received during plan development process.
- Make the TIP and Project Priorities drafts and final documents available on the TPO website at www.ecrc.org, a print copy of the current plan is available upon request.
- Hold public meetings at convenient times and accessible locations.
- Seek out and consider the needs of those traditionally underserved by existing transportation systems, including but not limited to, low-income and minority households.
- Coordinate with the statewide transportation planning public involvement and consultation processes under 23 C.F.R. Subpart B, as described in the FDOT MPO Program Management Handbook.
- Periodically review the effectiveness of the procedures and strategies contained in the participation plan.
- When significant written and oral comments are received on a draft TIP or Project Priorities as a result of public involvement, a summary, analysis, and report on the disposition of comments shall be made part of the final documents.

- If the final Project Priorities/TIP differ significantly from the one made available for public comment or raises new material issues, an additional opportunity for public comment must be made available.
- When the Metropolitan Planning Area (MPA) includes Indian Tribal Lands, the TPO shall appropriately involve the Indian Tribal Government(s).
- When the MPA includes federal public lands, the TPO shall appropriately involve the federal government.

#### General techniques proven effective include:

- Provide a 30-day public review and comment period for the draft Project Priorities documents.
- Promote development of the Project Priorities and TIP through news releases and social media, and eblast to TPO board and advisory committees, partners, stakeholders, community groups, and interested parties. (subscribe online at <a href="https://www.ecrc.org">www.ecrc.org</a>).
- Hold public workshop(s) and implement additional project-specific outreach, as needed, to special populations during the Project Priorities process.
- Coordinate public outreach to community groups (with emphasis on the underserved).
- Include public input collected at workshops in the draft Project Priorities and TIP.
- Include in the public notice of the TPO board meeting when the draft Project Priorities and TIP are to be presented for review and adoption.
- Provide the public with an opportunity to comment during public forum when the draft Project Priorities and TIP are presented for review and adoption to the TPO board and advisory committee meetings.
- Publish adopted Project Priorities and TIP interactive site (provided by FDOT) on website at www.ecrc.org, a print copy of the current plan is available upon request.
