CALL TO ORDER/INVOCATION/PLEDGE/BOARD MEMBER ROLL CALL

Chair Wright called the meeting to order. The prayer was led, and the pledge of allegiance recited. Mary Beth Washnock called the roll.

APPROVAL OF AGENDA

<u>Commissioner Barry moved to approve the agenda. Councilmember Bare seconded the motion, and it was unanimously approved.</u>

PUBLIC FORUM

Ben Kiesler, Associate Pastor for Brownsville Church, spoke on behalf of Senior Pastor Dr. Evon Horton. Ben Kiesler stated that Dr. Horton wanted to express his strong encouragement to raise priority to complete the full road diet for West Cervantes Street. Dr. Horton's statement read that that the traffic calming measures, which were part of the full road diet recommended by the engineering firm, have been extremely effective in eliminating pedestrian fatalities and demonstrated that business development can and does occur with traffic calming. Ben Kiesler further read from Dr. Horton's statement that for Brownsville to succeed as a turnaround community, business rebirthing needed to take

place and could be achieved through the full road diet to include reducing the speed limit from the current 30 miles per hour to 25 miles per hour, reducing lanes from four to two, and adding on-street parallel parking and bike lanes. Dr. Horton recommends that this would be most beneficial for the span of Cervantes Street from Pace Boulevard to Dominguez Street.

FDOT/ALDOT/ UPDATES:

1. FDOT Update - Bryant Paulk, AICP, or Christy Johnson, AICP, FDOT Urban Liaison

Bryant Paulk informed the board about an upcoming resurfacing project on SR 292 (Sorrento Road). This resurfacing project is scheduled from Bauer Road, eastward to Gulf Beach Highway. Legislative funds will help add paved shoulders to this corridor. Bryant Paulk stated that this project is under design and there will be a virtual project update on Wednesday, June 19th. This project has a letting date of May 2025, and a construction estimate of \$8 million dollars.

2. ALDOT Update - Vincent Beebe, P.E., ALDOT

Vince Beebe informed the board that the Foley Beach Express and Baldwin Beach Express have recently been acquired by ALDOT and are now toll free. Maintenance is working to start removing those toll plazas starting June 16th. Vince Beebe reported that the Waterways Bridge is currently under construction and looking to be completed in 2026.

4. ENCLOSURE E - ALL COMMITTEES - Consideration of Resolution FL-AL 24-24 Approving the Selection of a Firm for Signal Operations Contract - Jill Nobles, ECRC Staff

Jill Nobles stated that two RFQ packets were received by the May 17, 2024, deadline. The deadline was then extended to May 31, 2024, to gain additional submittals. No additional RFQ packets were received. The selection review committee met on June 3, 2024, to rank all proposals. The two firms that submitted RFQ packets were DRMP Inc. and SRF Consulting Group. After reviewing the firms using the presented scoring factors, staff recommended the TPO vote to move forward with DRMP.

Council Member Bergosh moved to authorize the TPO chair to sign Resolution FL-AL 24-24 approving the top ranked firm for Signalization Consultant Continuing Services and authorizing the chair or ECRC CEO to execute the Joint Participation Agreement with Florida Department of Transportation and a memorandum of agreement between the Florida-Alabama TPO and DRMP. Commissioner Barry seconded the motion, and it was unanimously approved.

FDOT requires the CMP for all Florida TPOs. The CMP major update occurs every five years to coincide with the LRTP update. The CMP involves an eight step process and ties back to the seven adopted LRTP Goals and the ECRC Seven-Layer Cake initiative supporting Target Zero / Vision Zero. The CMP identifies performance measures and targets to reduce travel demand, improve safety, encourage active transportation modes, provide reliable and efficient operation, and promote system preservation.

An important element in the development of the FL-AL 2050 LRTP is the understanding of available revenue which will be used to develop the Cost Feasible Plan. The FDOT 2050 Revenue Forecast Handbook identifies a reduction in mobility funding (approximately 65%) from the 2045 LRTP cycle as determined by the FDOT August 2022 Revenue Estimating Conference based on a decline in forecast tax receipts, decline in vehicle registration fees, and a reduction in fuel taxes due to greater future fuel efficiency and vehicles trends.

ORIGIN OF SUBJECT: FHWA. FDOT, and ALDOT

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The Adjusted Urban Area Boundary Map is used to establish the boundary between urban and rural areas for Federal Highway Functional Classification purposes and is reviewed every ten years as part of the Census. It is based on FHWA's "Highway Functional Classification Concepts, Criteria and Procedures" 2013 Edition. The Adjusted Urban Area Boundary and the Federal Classification Maps are to be reviewed by ALDOT and FDOT by December 2024 and approved by FWHA by April 2025.

The attached Urban Area Boundary Maps illustrate the differences between the 2010 and 2020 Census. The attached Federal Functional Classification Maps for Escambia, Santa Rosa, and Baldwin counties have been developed by FDOT and ALDOT with input from the TPO and local governments. Listed below are the proposed changes from 2010 to 2020 for the Federal Functional Classifications.






2010 Adjusted Urban Area Boundary



2020 Adjusted Urban Area Boundary




2020 Escambia County Functional Classification Map





Federal Functional Classification Definitions

<u>Arterials</u> – Arterial system provides the highest level of mobility at the highest speed, for long, uninterrupted travel. Arterials generally have higher design standards than other roads, often with multiple lanes and some degree of access control.

<u>Interstates</u> – Interstates are the highest classification of Arterials and were designed and constructed with mobility and long-distance travel in mind. Since inception the Interstate System has provided a superior network of limited access, divided highways offering high levels of mobility while linking the major urban areas of the United States. Federal Aid Eligible.

<u>Other Principal Arterials</u> – These roadways serve major centers of metropolitan areas, provide a high degree of mobility and can also provide mobility through rural areas. Unlike their access- controlled counterparts, abutting land uses can be served directly. Federal Aid Eligible.

<u>Minor Arterials</u> – Minor Arterials provide service for trips of moderate length, serve geographic areas that are smaller than their higher Arterial counterparts and offer connectivity to the higher Arterial system. Federal Aid Eligible.

<u>Collectors</u> – Collectors provide a lower degree of mobility than arterials. They are designed for travel at lower speeds and for shorter distances. Collectors are typically two-lane roads that collect and distribute traffic from the arterial system. In order to bridge this gap, Collectors must and do provide access to residential neighborhoods.

<u>Major Collectors</u> – Major Collector routes are longer in length; have lower connecting driveway densities; have higher speed limits; have higher annual average traffic volumes; than their Minor Collector counterparts. Federal Aid Eligible.

<u>Minor Collectors</u> – Minor collectors provide service to smaller communities not served by a higher class facility. These routes connect major thoroughfares to diffused areas, such areas include the primary connection to a farming area consisting of large acreage tracts or scattered small residential developments. These roads that are outside of the urban boundary are classed as Rural Minor Collectors. However, these roads that are inside the urban boundary are classed as Urban Minor Collectors. Urban Minor Collectors are Federal Aid Eligible. Rural Minor Collectors are Non-Federal Aid Eligible.

ORIGIN OF SUBJECT: Federal Government 2 CFR 200/Subpart E Cost Principles

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The UPWP is a required product of the TPO. It describes the planning work tasks and budget for the TPO fiscal year (July through June). As defined in the Code of Federal Regulations, the UPWP is a statement of work identifying the planning priorities and activities to be carried out within a metropolitan planning area. At a minimum, a UPWP includes a description of the planning work and resulting products, who will perform the work, and the source(s) of funds (23 C.F.F. 450.104). The TPO adopts a new UPWP every other year along with an annual revision at the end of the first year.

TPO work elements include, but are not limited to:

- Program Development
- Long Range Transportation Planning
- Data Development and Management
- Short Range Transportation Planning
- Plans and Studies
- Public Involvement
- Alabama Planning

Funding sources for these work elements include, but are not limited to:

- PL (Planning)
- SU (Federal Urbanized)
- CM (Congestion Management)
- FTA 5305
- FTA 5316 (Job Access Reverse Commute)

In October 2021, the TPO adopted the Federal 10% De Minimis indirect rate. This rate was used when calculating the budgets for the FY 2025 – FY 2026, which was adopted by Resolution FL-AL 24-15, during the April 2024 TPO meeting. Since this time, the Federal Government has changed the De Minimis allowance to 15% per 2 CFR 200/subpart E Cost Principles. Staff are recommending that the TPO officially adopt this new rate and cost principal guidance based upon 2 CFR 200/subpart E. This will allow staff to inform the Florida Department of Transportation (FDOT) and Alabama Department of Transportation (ALDOT) so the process to make necessary UPWP budgetary changes, as applicable to the funding sources listed above, can begin.

The Financial Agreement between the TPO and FDOT will need to be amended, it is requested that the new De Minimis rate of 15% become effective January 1, 2025.

ORIGIN OF SUBJECT: Federal Transportation Legislation Moving Ahead for Progress in the 21st Century Act (MAP-21), Fixing America's Surface Transportation (FAST) Act, and Infrastructure Investment and Job Act (IIJA), Federal Highway Administration (FHWA), and Florida Department of Transportation (FDOT)

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: Transportation Planning Organizations (TPOs) are required to adopt targets for Safety Performance Measures annually, by February 27. Since the Florida-Alabama TPO Planning Boundary crosses state lines, the TPO must plan and program projects to contribute towards separate targets—one set for each state in which the planning area boundary extends state lines. The TPOs can either accept the Department of Transportation (DOT) targets or establish their own targets. From 2018 - 2023 the Florida-Alabama TPO adopted, by resolution, the DOT targets for Safety Performance Measures. The necessary language for Safety Performance Measures was incorporated into the FY 2019-2023, FY 2020-2024, FY 2021-2025, FY 2022-2026, FY 2023-2027, and FY 2024-2028, and FY 2025-2029 Transportation Improvement Programs (TIPs) and amendments to the TIP. Any future amendments to the 2045 Long Range Transportation Plan will also need to incorporate language for Performance Measures. Because of these previous TPO actions, Resolution 24-28 has been worded to continue with the state targets for Safety as it needs to be adopted by February 27, 2025.

If a TPO agrees to support a State Highway Improvement Program Target, the TPO would:

- Work with state and safety stakeholders to address areas of concern for fatalities or serious injuries within the metropolitan planning area.
- Coordinate with the State and include the safety performance measures and the State's Highway Improvement Program targets for those measures in the Metropolitan Transportation Plan.
- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect
 of the Transportation Improvement Program toward achieving Highway Safety Improvement
 Program targets in the Metropolitan Transportation Plan, linking investment priorities in the
 Transportation Improvement Program to those safety targets.

If a TPO establishes its own Safety Performance Target, the TPO would:

- Establish Highway Safety Improvement Program targets for all public roads in the metropolitan planning area in coordination with the State.
- Estimate vehicle miles traveled (VMT) for all public roads within the metropolitan planning area for rate targets.
- Coordinate with the state and include the safety performance measures and the TPO's safety targets for those measures in the Metropolitan Transportation Plan.

- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect of the Transportation Improvement Program toward achieving Highway Safety Improvement Program targets in the Metropolitan Transportation Plan, linking investment priorities in the Transportation Improvement Program to those safety targets.

FDOT has adopted a "Vision Zero" target for the five safety measures. This "Vision Zero" target is based on the Florida Strategic Highway Safety Plan. The Alabama Department of Transportation (ALDOT) has a "Toward Zero Death Initiative." The table below illustrates the targets the TPO adopted from 2018 through 2024 as well as DOT targets for 2025. The targets are based on a five-year rolling average. 2018 (2012-2016), 2019 (2013-2017), 2020 (2014-2018), 2021 (2015-2019), 2022 (2016-2020), 2023 (2017-2021), 2024 (2018-2022), and 2025 (2019-2023). However, please note the 2025 five year rolling average has not yet been made available by FDOT.

FDOT'S METHODOLOGY

Number of Fatalities

Based on statistical forecasting, the five-year rolling average for total fatalities on Florida's roads was forecasted to be 3,441.8 in 2023. Florida's target for fatalities is zero in 2025. The data forecast indicates Florida's five-year rolling average for fatalities will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of traffic fatalities on Florida's roads.

Number of Serious Injuries

Based on statistical forecasting, the five-year rolling average for serious injuries on Florida's roads was forecasted to be 16,380.6 in 2023. Florida's target for serious injuries is zero in 2025. The data forecast indicates Florida's five-year rolling average of serious injuries will continue to trend downward. The FDOT State Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries on Florida's roads.

Fatality Rate

Based on statistical forecasting, the five-year rolling average for fatality rate per 100 million Vehicle Miles Traveled on Florida's roads was forecasted to be 1,543 in 2023. Florida's target for fatality rate per 100 million vehicle miles traveled is zero in 2025. The data forecast indicates Florida's five-year rolling average of fatality rate per 100 million Vehicle Miles Traveled will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the fatality rate per 100 million Vehicle Miles Traveled on Florida's roads.

Serious Injury Rate

Based on statistical forecasting, the five-year rolling average for serious injury rate per 100 million Vehicle Miles Traveled on Florida's roads was forecasted to be 7.344 in 2023. Florida's target for serious injury rate per 100 million Vehicle Miles Traveled is zero in 2025. The data forecast indicates Florida's serious injury rate per 100 million Vehicle Miles Traveled will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries per 100 million Vehicles Miles Traveled on Florida's roads.

Total Number of Non-Motorized Fatalities and Serious Injuries

Based on statistical forecasting, the five-year rolling average for the number of non-motorized fatalities and serious injuries on Florida's roads was forecasted to be 3,148.2 in 2023. Florida's

target for number of non-motorized fatalities and serious injuries is zero in 2025. The data forecast indicates Florida's number of non-motorized fatalities and serious injuries will continue to trend downward. The FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of non-motorized fatalities and serious injuries on Florida's roads.

This performance target was developed through a trend line analysis of the five-year moving average for fatalities. This analysis determined the 5-year moving average trend of fatalities in Alabama. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term fatality trends.

Number of Serious Injuries

This performance target was developed through a trend line analysis of the five-year moving average for serious injuries. This analysis determined the 5-year moving trends of serious injuries in Alabama. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term serious injury trends.

Fatality Rate

This performance target was developed using the fatalities and a project number of Vehicle Miles Traveled (VMT) from the previous year. This target represents the projected fatalities as a ratio of 100 million VMT. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce serious injury rate trends.

Serious Injury Rate

This performance target was developed using the serious injuries and a project number of Vehicle Miles Traveled (VMT) from the previous year. The target represents the projected serious injuries as a ratio to 100 million VMT. This target supports the Highway Safety Improvement Plan by helping Alabama focus its strategy, or direction, and making decisions on allocating its resources to reduce long-term serious injury rate trends.

Number of Non-Motorized Fatalities and Serious Injuries

This performance target was developed through a trend line analysis of the five-year moving average for non-motorized fatalities and serious injuries. This analysis determined the non-motorized fatalities and serious injuries 5-year moving average trend of non-motorized fatalities and serious injuries. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term non-motorized fatalities and serious injuries trends.


The TPO approves the 2025 Beach Traffic Monitoring proposal with DRMP, Inc. using \$57,400 of TPO funds (FDOT FPID #: 412545-2-88-01). Additionally, the TPO requests Escambia County and Santa Rosa County to pay their respective shares of \$38,267 and \$19,133.

Monitoring Task for 2025

Background:

The Florida-Alabama Transportation Planning Organization (FL-AL TPO) has requested that DRMP, as a part of the services provided under the ongoing traffic engineering support contract with the FL-AL TPO, provide active traffic monitoring/operations on weekends and evenings for the 2025 summer tourism season. This document generally describes the anticipated services.

Description of Work Activities:

The requested services include monitoring traffic conditions on Pensacola Beach Road and on Navarre Beach Causeway during prescribed hours on weekends and during special events throughout the tourism season. The prescribed schedule is attached to this document. DRMP will monitor the traffic flow on the corridors via video feed and adjust signal timing as needed to improve traffic operations. All signal timing adjustments will be based on performance criteria approved by the FDOT. DRMP will provide the monitoring services at all times prescribed in the attached schedule, however, it is anticipated that there may be weather conditions or other events that cause the expected traffic volumes to be low. In this event, DRMP will seek approval from the local agency prior to ceasing monitoring activity. Services shall include active local agency communication and reporting during monitoring and provide a weekly written report of activity.

Compensation:

Compensation for the services will be based on actual time committed to the effort at approved contract rates. This task shall be invoiced and compensated under the terms listed in the ongoing Professional Consulting Services Contract Agreement between the FL-AL TPO and DRMP. The total estimated staff-hour to monitor the season beach traffic is approximately 820 hours. Based on an average hourly rate of \$140, the total estimated cost is **\$114,800.00** for this effort.

The FL-AL TPO is requesting compensation support from Escambia County and Santa Rosa for the 820 hours to monitor Pensacola Beach and Navarre Beach traffic as was done in 2023 and 2024. The amount requested from each agency will be based on the peak volumes of traffic recorded at each beach in the 2024 season. The amount of SB traffic counted at Pensacola Beach divided by the total amount of SB traffic at both beaches is approximately 2/3, with Navarre Beach making up the other 1/3 of the total traffic. The FL-AL TPO will split the total cost with the agencies. Based on this, the total compensation



shall be split 2/3 to Escambia County at **\$38,267.00** and 1/3 to Santa Rosa County at **\$19,133.00**. See Table 1 below for the cost share breakdown.

BACKGROUND: The MPOAC is a statewide organization created by the Florida Legislature to address transportation issues of common interest to all urbanized areas and Metropolitan Planning Organizations (MPOs) in the state. The MPOAC is made up of MPO members representing each MPO in the state.

ORIGIN OF SUBJECT: Florida–Alabama TPO Unified Planning Work Program (UPWP) Task 5: Plans and Studies

LOCAL GOVERNMENT ACTION NEEDED: None

BACKGROUND: The Bipartisan Infrastructure Law (BIL) established the new SS4A discretionary program, with \$5 billion in appropriated funds over 5 years (2022-2026). The SS4A program funds regional, local, and tribal initiatives through grants to prevent roadway deaths and serious injuries.

On September 5, 2024, ECRC was awarded a \$10 million grant from USDOT as part of the National Roadway Safety Strategy to reduce traffic fatalities. As a recipient of an SS4A Planning and Demonstration grant, ECRC, in partnership with Escambia County, will deploy innovative technological improvements and evaluate the safety impact of Intelligent Transportation System (ITS) improvements on two of Pensacola's highest crash rate segments, Fairfield Drive and Pensacola Boulevard. These two corridors have been identified through the Emerald Coast Safety Action Plan, having critical issues such as low lighting, bicycle and pedestrian incidents, and left-turn crashes.

Along Fairfield Drive, from Mobile Highway to Texar Drive, nearly 2,000 crashes were reported from January 1, 2019 through December 31, 2023, including five fatal and 39 serious injury cases. Crashes under dark conditions represented approximately 22% of overall crashes but more than 40% of fatal and serious injury crashes.


Similarly, Pensacola Boulevard, from "W" Street to Brent Lane reported more than 550 crashes in that same timeframe, including one fatal and eight serious injury crashes. However, this segment presented different obstacles, specifically for pedestrians.



The Transportation Alternatives (TA) Set-Aside provides funding for programs and projects consistent with the Infrastructure Investment and Jobs Act (IIJA) also known as the Bipartisan Infrastructure Law. These set-aside funds include all projects and activities defined as TA: on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation, community improvement activities, environmental mitigation, and projects for planning, designing, or constructing boulevards and other roadways largely in the right-of-way of formerly divided highways.

Projects located within the TPO will need to be prioritized by their respective TPO. Projects located outside the TPO areas will need to be prioritized by the ECRC. 

1. FDOT Update - Bryant Paulk, AICP, or Christy Johnson, AICP, FDOT Urban Liaison
