#### VI. INFORMATION ITEMS:

1. Comprehensive Operations Analysis Implementation Updates – Mr. Tyrone Parker, Okaloosa County

Phase 1

- Service modification route 30 in Destin, more efficient service
- Connections with route 32 and 33
- Started service May 20, 2024

Mr. Parker said the numbers look good with an 8 % increase in June. Next step of the COA is to be presented for full adoption to the Okaloosa BOCC in August. If approved the next phase will be Fort Walton Beach and Airport Service. Phase 3 would be additional Crestview service.

Councilwoman Brown said she is glad the service is moving forward and hoping for more Crestview service with possible feeder routes.

#### 2. EC Rider Updates – Mr. Tyrone Parker, Okaloosa County

Mr. Parker said they have received 1.6 million Capital Improvement grants for both fixed route and paratransit service. We have ordered 12 vehicles 5 for fixed and 7 for paratransit service. They have recently received 2 new vehicles for paratransit and staff are currently training on the new vehicles. These grants are dated back to 2022.



Mr. Parker stated there is currently one staff vacancy in maintenance but have candidates and are hoping to have the position filled in the next few weeks.

Councilwoman Brown remembers in previous years all the vacancies and issues but appreciates the hard work and improvements in the system.

#### 3. MV Transportation Updates – Ms. Lakeshia Brown

Managers have been riding the routes to help evaluate, improve service, and help drivers. MV is currently only short three drivers but have two in class right now.

Ms. Brown said it is very important to support staff and connect with the community. Listen to the riders and drivers. We are working on new software kinks with the drivers assistance.

Mayor Hood said it is important you talk and work with your drivers they are the bridge between management and the riders.

Ms. Brown said it is all about keeping open communications.

Tyrone Parker stated after issues were identified, we addressed them right away updating the software and website.

Councilman Stauffer said since joining the Board I now see EC Rider everywhere and I am impressed with the presence and the management style.

Lakeshia Brown said they hosted a picnic for all staff and family members as a team bonding event with over 70 people and are planning three future events to show our appreciation and that we care about our staff. Everything is a team effort, and I am thankful for the great team we have.

#### VIII. PUBLIC FORUM

Mr. Paul VanRisseghem stated we need service to the airport, and he is glad to see the plan for service. He suggested a tourist pass. Mr. VanRisseghem said highway 98 is very congested and there are issues with getting personnel to base. He said



light rail system would be a great help to the military, and we need to continue to look to the future.

Mayor Hood said we appreciate your input; I know bus passed were mentioned at previous meetings and should be available.

Mr. Parkers said they currently offer 30 day and 15 day passes, but he will look into a tourist pass.
